# TRAINING AND EXERCISE PLAN PURPOSE & METHODOLOGY

## Purpose

Washington State trains and exercises to improve disaster preparedness and validate plans to prevent, mitigate, respond to, and recover from the threats and hazards that pose a risk to the people, property, and communities of the state.

The *Washington State Training and Exercise Plan (TEP) 2019-2021* provides a roadmap for Washington to follow in accomplishing the priorities developed at the 2018 Training and Exercise Planning Workshop based on the hazards outlined in the Washington State Enhanced Hazard Mitigation Plan Risk and Vulnerability Assessment (HIVA) and the Washington State Enhanced Mitigation Plan, and informed by the Washington State Core Capability Strategic Planning Framework, part of the State Preparedness System, and in alignment with [Presidential Preparedness Directive 8](#) <sup>[1]</sup>(PPD-8); state executive guidance; and stakeholder training and exercise plans and forecasts. Considered a living document, the TEP may be updated and refined as necessary.

Included in the *TEP 2019-2021* are the Training and Exercise forecasts, which provide a graphic illustration of the proposed activities, forecasted for the calendar years 2019-2021. It is representative of the natural progression of training and exercises that take place to fulfill training and exercise requirements in accordance with Revised Code of Washington 38.52 and meets the guidance of implementing a progressive exercise approach with the Homeland Security Exercise and Evaluation Program (HSEEP).

## An All-Hazards Approach

The [National Preparedness Goal](#), released in September 2015, defines preparedness of the whole community for all types of disasters and emergencies. The National Preparedness Goal describes 32 preparedness activities called Core Capabilities (listed on Appendix A). Each of these Core Capabilities are tied to a capability target. The National Preparedness Goal organizes the Core Capabilities into the five mission areas: Prevention, Protection, Mitigation, Response, and Recovery.

Each organization or agency represented in this TEP needs the flexibility to determine how they apply their resources, based on the all the identified threats and hazards and choose training and exercise strategies that are most relevant to them bridging the gaps identified in their targets.

## Washington State Training and Exercise Plan Methodology

Through the implementation of the Homeland Security Exercise and Evaluation Program (HSEEP), organizations and agencies can use training and exercises to improve current and

required Core Capability rating levels, identify gaps, and overcome shortfalls. Those forecasted training and exercise activities are outlined annually in this Training and Exercise Plan (TEP).

The planning process and methodology for the annual development of the TEP is conducted in four phases:

Phase I: Capabilities Assessment

Phase II: Prioritization of Training and Exercises

Phase III: Conduct of the annual Training and Exercise Planning Workshop (TEPW).

Phase IV: Implementation of the TEP

### ***Phase I - Capabilities Assessment***

Washington State aligns with PPD-8, completing and submitting a Stakeholder Preparedness Review to FEMA annually. This report provides a detailed state-level assessment of the 32 Core Capabilities viewed through the lens of our most critical hazards identified in the Washington State Threat Hazard Identification and Risk Assessment (THIRA). The Capabilities Assessment provides a gap analysis, by Core Capability, for each desired outcome and capability target identified in the THIRA. This assessment serves as a trigger and foundational input for developing the multi-year TEP each year.

The Capabilities Assessment is conducted through a FEMA-defined 1-5 assessment rating for each POETE (**P**lanning, **O**rganization, **E**quipment, **T**raining, and **E**xercise) element of each Core Capability; a set of standardized questions to guide the rating process; and a brief statement of gaps that must be filled to raise an element to a higher level of capability.

The rolled-up and analyzed data from the Capabilities Assessments are then used as one statewide assessment for Washington State. This assessment becomes the Washington State Preparedness Report.

### ***Phase II – Prioritization of Training and Exercises***

After the Capabilities Assessment is completed, the next phase in the Preparedness Cycle is determining the priority training and exercises that bridge gaps in capability targets. Along with the gaps identified in Phase I, the state training and exercise program supervisors consider other critical inputs, hazards, and assessments such as: recent After-Action Reports, major changes in law-policies-plans, executive guidance, and the HIVA, to fully inform an All-Hazards, Core capability-based training and exercise priorities and forecast. Additionally, prior to the annual TEPW, Regional Coordinators and State Agency Representatives are expected to forecast their anticipated trainings and exercises for the next three calendar years: year one by month; year two by quarter; and year three semi-annually. Using the three-year forecasts, the Training and Exercise (T&E) Section of Washington State Emergency Management Division gathers Regional Coordinators and State Agencies and conducts the annual TEPW to strategically look at the forecasted training and exercise activities for the next three years to determine:

1. Do the forecasted T&E activities fulfill the priority gap needs identified through the prioritization of those capabilities?

2. Are there T&E activities that can be consolidated or collaborated on to eliminate redundancies and effectively and efficiently utilize limited funding and resources?

### *Phase III – Conduct of the TEPW*

The objective of the annual Washington State Training and Exercise Planning Workshop (TEPW) is to jointly develop a Training and Exercise Plan (TEP) for Washington State. The TEP identifies an organization or agency's assessed gaps in capabilities and their strategy to overcome these gaps through training and exercise. The overall product from the TEPW is the agreed-upon forecast of training and exercises that the state agrees to sponsor or coordinate and those that an organization or agency will undertake, to build, improve, validate, or sustain its capabilities.

### *Phase IV – Implementation of the TEP*

Following the TEPW, the Training and Exercise Staff consolidate and build the multi-year Training and Exercise Plan. The TEP is published within 90 days of the conduct of the TEPW. Events forecasted in the TEP are planned, coordinated, funded, and delivered as close to the planned dates as possible. The TEP is a working document and, as such, the forecasted events should not be considered a binding agreement. There will be the very best effort given to execute the events as they are listed however, during the year priorities may shift, interest may dwindle, staff may depart, and disaster responses may take precedence over the listed event. Events that are not executed on the listed date and time will have proper justification and the first option will be to reschedule the event. If the event is not able to be rescheduled, cancellation of the event will ultimately be the decision of the host jurisdiction/agency.

Events listed in the TEP will be submitted in the Emergency Management Performance Grant work plan. Events that are cancelled or rescheduled will be reported in the EMPG quarterly report.

Delivery of all the activities listed in the TEP is a goal that cannot be conducted by the Washington State EMD Training and Exercise staff alone. In this endeavor, we seek the expertise and experience of professional Emergency Management professionals from across the state to assist with the conduct of training and exercises. Washington State EMD will identify, recruit, and certify talented individuals from our pool of stakeholders to assist with implementation of the TEP.

## **Training and Exercise Program Management**

Training and Exercise Program Management involves a collaborative approach that integrates resources, organizations, and individuals to identify and achieve program training and exercise priorities. Through the management of training and exercise programs, stakeholders provide oversight to specific training and exercise activities sustained over time. An effective training and exercise program maximizes efficiency, resources, time, and funding by ensuring that training and exercises are part of a coordinated and integrated approach to building, sustaining, and delivering Core Capabilities. Below is an overview of the components of the State Training Program and State Exercise Program.

## State Training Program Goal and Objectives

### Goal and Objectives

The program goal is to facilitate quality whole-community preparedness training opportunities.

To meet this goal, the State Training Program follows four (4) objectives.

#### Objective 1: Support Stakeholder Emergency Management Training Needs Assessments

Throughout the year, WA Emergency Management Division (EMD) employees participate in meetings and workshops with stakeholders to determine gaps in training against FEMA's 32 Core Capabilities. The assessment procedure uses a rating of 1-low to 5-high against each of the POETE elements. The following table explains the FEMA rating language organizations and jurisdictions use to rate Core Capability levels in the Training element.

<b>1</b>	<b>Very few (0-20%) relevant persons have completed all relevant courses</b>
<b>2</b>	<b>Few (21-40%) relevant persons have completed all relevant courses</b>
<b>3</b>	<b>Many (41-60%) relevant persons have completed all relevant courses</b>
<b>4</b>	<b>Most (61-80%) relevant persons have completed all relevant courses</b>
<b>5</b>	<b>All or nearly all (81-100%) relevant persons have completed all relevant courses</b>

Prior to the annual Training and Exercise Planning Workshop (TEPW), the State Training Program staff will distribute a training and exercise forecast worksheet to all its stakeholders. This forecast is for the stakeholders to summarize their training and exercise needs over a multi-year period. The forecasts help to identify assistance needed from Washington EMD in coordination and conduct of courses, give predictability in scheduling events over a multi-year period, and summarize training and exercise events that support workplans associated with grants.

#### Objective 1 Activities:

- Participate in stakeholder training needs assessments;
- Provide technical assistance with stakeholder training needs assessment when requested; and
- Support stakeholder development of training and exercise forecasts derived from needs assessments.

#### Objective 2: Participate in the Annual Training and Exercise Planning Workshop (TEPW)

The purpose of the annual TEPW is to develop a multi-year Training and Exercise Plan (TEP) for Washington State as required by federal grant guidance. The multi-year TEP identifies a stakeholder's training and exercise priorities as articulated in that stakeholder's strategy. The stakeholder should identify the capabilities that are most critical to achieving those priorities and then outline a multi-year schedule of training courses that will raise their POETE rating level identified in their training needs assessment, above.

Analysis of all stakeholder training needs assessments, forecasts, and requests for assistance will be conducted during and immediately following the TEPW. Requests are weighed against many factors including budget, instructor availability, and resources available. Washington State EMD staff will make every effort to fill training requests; however, not every request can be accommodated. Stakeholders must prioritize their training requests and clearly label their most critical needs.

**Objective 2 Activities:**

- Analyze stakeholder training and exercise forecasts;
- Develop multi-year training and exercise calendar; and
- Publish multi-year Training and Exercise Plan (TEP).

**Objective 3: Implement the Multi-Year Training and Exercise Plan (TEP)**

Washington EMD Training and Exercise staff is committed to helping stakeholders by linking them to the training they desire. This involves a collaborative effort between the office and the stakeholder in finding the right course at the right time in the right location to ensure stakeholders are provided the best opportunity to reach their own training program goals and objectives. In addition to linking stakeholders to training resources, the Washington State EMD staff will provide support in training development, training event coordination, instruction, and course materials.

The State Training Program staff strives to provide and coordinate training to meet all-hazard performance gaps that are determined to have unmet training needs. These unmet training needs must be based on a performance needs analysis, an After-Action Report/Improvement Plan, or a pre-identified capability shortfall.

**Objective 3 Activities:**

- Coordinate local delivery of consortium courses;
- Coordinate and conduct state-delivered (G and L series) courses;
- Process Department of Homeland Security-sponsored resident course applications;
- Coordinate and conduct State Emergency Operations Center (EOC) Staff Training and Exercise Program activities;
- Recruit, certify, and maintain a statewide cadre of instructors
- Enforce state-certified instructor requirements and support National Incident Management System (NIMS) Training Program policies; and
- Support emergent training needs on a case-by-case basis.

**Objective 4: Evaluate Training Program Effectiveness to Improve Program Quality**

To measure program effectiveness, the State Training Program conducts three types of evaluations: goals-based, process-based, and outcomes-based.

**Goals-Based (Internal):** This evaluation determines if training activities and projects meet the defined goal of the program. This evaluation focuses on prioritization of activities and establishment of timelines to assist in meeting the desired goal.

**Process-Based (Internal and External):** This evaluation focuses on the processes in place that guides the State Training Program day-to-day activities. This evaluation type analyzes our staff and stakeholder requirements, procedures in conducting program activities, and system effectiveness.

**Outcomes-Based (External):** This evaluation focuses on the stakeholder. Outcomes focus on stakeholder satisfaction and the enhancement of their knowledge, skills, and abilities. It also captures overall satisfaction from the stakeholder regarding course conduct and instructor competencies.

**Objective 4 Activities:**

- Collect and analyze stakeholder feedback through evaluation forms and surveys;
- Prioritize department and division training needs for state-published After-Action Reports; and
- Incorporate analysis into future program activities.

## *State Exercise Program Components*

The State Exercise Program integrates all exercises, exercise-related courses, and exercise technical assistance to local jurisdictions into one comprehensive program. It supports the state's overarching priority preparedness activities, or Core Capabilities.

The Washington State Exercise Program is guided by the following priorities:

- Build an integrated statewide exercise program that incorporates activities of existing exercise programs; including a State Corrective Action Program (CAP).
- Conduct exercises that: enhance State EOC response; align with statewide priorities; and enhance overall WA preparedness.
- Provide exercise technical assistance and direct support to locals, state agencies and tribal partners.

**State Exercises:** The State Exercise Program designs, develops, and conducts state-local workshops, drills, and functional exercises that test emergency operations, emergency communications, response, recovery, and multiagency coordination. Exercises support the goals of emergency management within the State of Washington, and its stakeholders, including local jurisdictions, tribes, cross-border states/provinces, military, and federal government.

**Local Exercises:** The State Exercise Program will design and develop one Threat-Based Tabletop exercise per year to be provided and facilitated by the local jurisdictions. All exercise documentation will be provided to the local jurisdictions (Situation Manual, Presentation, Player Handouts and Feedback Forms). The state will also facilitate the Tabletop exercise in two of the local jurisdictions; the jurisdiction will be chosen based on the application for assistance.

**Building Block Approach:** The State Exercise Program will utilize the Building Block Approach to all exercises. The Building Block Approach ensures successful progression in exercise design, complexity, and execution, and allows for the appropriate training and preparation to occur in the community conducting the exercise. By using this methodology, the state can ensure that the levels of exercise sophistication are tailored to each specific region or jurisdiction, while maintaining the same delivery strategy.

The baseline exercise progression for each jurisdiction is to move from a seminar or workshop to a tabletop exercise (TTX) to a functional exercise (FE), and finally, to a full-scale exercise (FSE). These exercise types allow for a logical progression of regional and jurisdictional preparedness by increasing in size, complexity, and stress factor, while allowing for significant learning opportunities that effectively complement, build upon, and directly lead into one another. This model will remain flexible enough to allow for the addition of, or inclusion of, other desired exercise types that the State of Washington may require. Finally, this exercise model allows for a cyclical approach to statewide exercises, which provides the state with a sustainable program for achieving higher degrees of overall preparedness.

**Homeland Security Exercise and Evaluation Program (HSEEP):** The HSEEP doctrine consists of fundamental principles that frame a common approach to exercises. A common methodology ensures a consistent and interoperable approach to exercise design and development, conduct, evaluation, and improvement planning, as depicted in the figure at right. Washington State has adopted the Homeland Security Exercise and Evaluation Program (HSEEP) as the State standard.



Washington State Emergency Management Division offers the HSEEP Training Course three times a year. The HSEEP Training Course is an interactive course that allows participants to share personal lessons learned and best practices while gaining practical experience.

**Master Exercise Practitioner Program (MEPP):** The MEPP goal is to increase the capabilities of participants in mastery of exercise program management and the overall exercise process in accordance with the policy, doctrine, practices, and tools in the HSEEP Program. [More info on MEPP](#)

**Community-Specific Integrated Emergency Management Courses (IEMC):** IEMCs are exercise-based training courses that place jurisdictions' emergency operations center personnel in realistic crisis situations within a structured learning environment. The jurisdiction selects the scenario(s) it wants to exercise; for example, a special event, earthquake, winter storm, or terrorist incident. Exercises are then developed to reflect the hazards or events facing the jurisdiction, the type of EOC used by the jurisdiction, and the organizations and agencies included in the jurisdictional emergency plans. **Technical Assistance:** Emergency Management Division staff are available to assist cities, counties, tribes and state agencies in the design, conduct, and evaluation of their exercises for all-hazards. This assistance can be provided in the form of: planning conferences, workshops, site visits, and technical review of exercise documents, exercise design, control, evaluation and State EOC exercise play. Please contact the State Exercise Program if you would like to request any form of technical assistance.

### ***2019-2021 State Exercise Program Priorities***

Due to the lessons learned in response and recovery of the 2014 SR530 Landslide Activation, 2015 and 2016 Wildland Fires that burned historically large acreage of land, and 2016 Cascadia Rising Series of Exercises, the state exercise program will focus on the lifesaving and life sustaining Core Capabilities to ensure an effective emergency response. Additional focus will be on the EMPG suggested capabilities and 'Mission Failure' priorities from the State Corrective Action Program. State-led exercises will entail many different aspects of all mission areas within the National Preparedness System. However, an emphasis for our state-led exercises will

test or validate emergency operation for one or several of these lifesaving and life sustaining core capabilities for the years 2019-2021:

- Critical Transportation
- Mass Care Services
- Operational Communications
- Operational Coordination
- Planning
- Public Health, Healthcare, and Emergency Medical Services
- Infrastructure Systems
- Situational Assessment
- Logistics and Supply Chain Management

As the state progresses through the exercise calendar and real-world activations, WA EMD reviews exercise and activation lessons learned to implement efficient and effective prevention, protection, mitigation, response and recovery corrective actions. Through the corrective action process, State-led exercises will incorporate the lessons learned to build state and local emergency management capability.



## STATE-SPONSORED TRAINING AND EXERCISE FORECASTS

The Washington State Training and Exercise Plan uses a progressive approach to forecast training and exercises based on Washington State's priority Core Capabilities. A progressive training and exercise program is a series of trainings and exercises tied to a set of common priorities.

These forecasts are designed to identify training and exercise activities for Washington State based off the critical needs identified at the annual Training and Exercise Planning Workshop. Additionally, local-specific training and exercise activities are captured based on local priorities and emergent needs.

The State Training forecasts are organized to focus on a monthly forecast for calendar year 2019, a quarterly forecast for calendar year 2020, and a semi-annual forecast for calendar year 2021. Calendar forecasts begin on next page.

Homeland Security Regions and their associated county and city forecasts are presented in Appendix D.

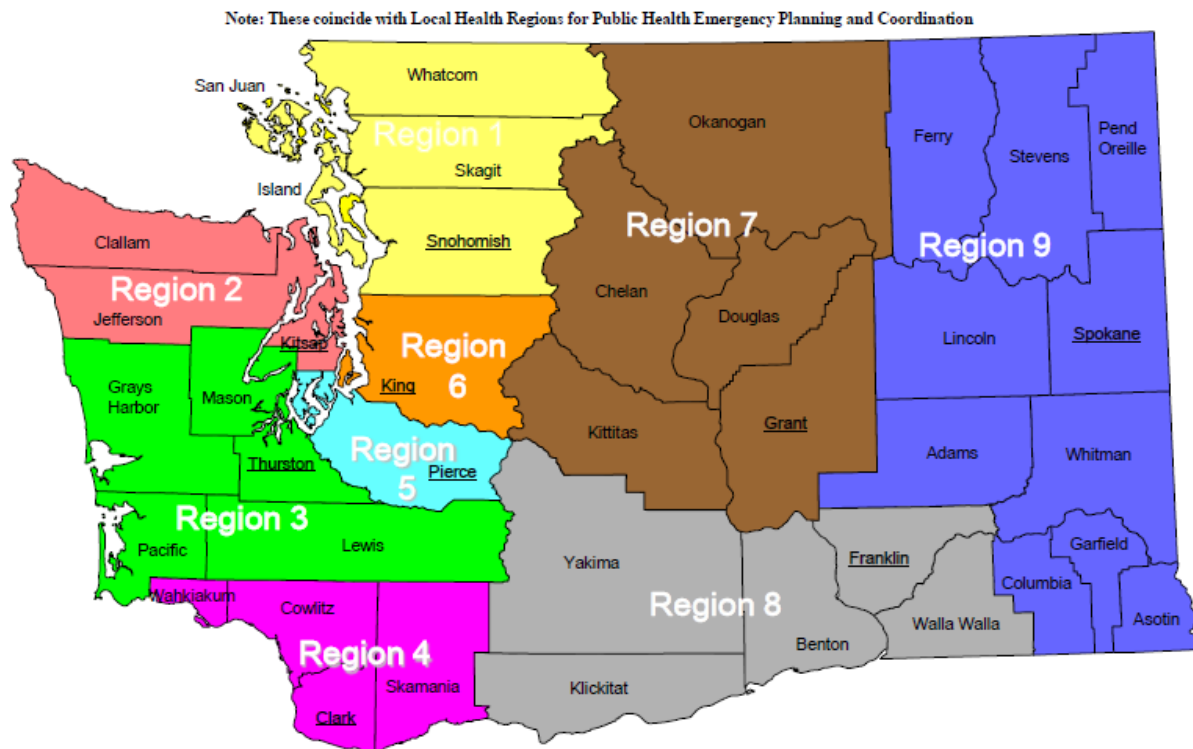

## APPENDIX C: NATIONAL TRAINING AND EDUCATION DIVISION (NTED)

Courses available through the Consortium partners, as well as courses offered by training partners can be accessed through FEMA's National Training and Education Division (NTED). Legacy training organizations from the DHS Preparedness Directorate and FEMA were consolidated under the umbrella of the newly created National Integration Center (NIC).

NTED provides tailored training to enhance the capacity of state and local jurisdictions to prepare for, prevent, deter, respond to, and recover safely and effectively from potential manmade and natural catastrophic events, including terrorism. To date, NTED has delivered training and broadcast information to over 2 million first responders.

### *NDPC Training Partners*

**Center for Domestic Preparedness (CDP):** Located in Anniston, Alabama, CDP a federally chartered Chemical, Biological, Radiological, Nuclear, and Explosives (CBRNE) civilian training center. The CDP began operations in June, 1998, and remains the only training center in the nation where civilian responders can train in a controlled environment for chemical agents and hazardous materials. On March 31, 2007, the Noble Training Facility (NTF) was transferred from the U.S. Fire Administration to the CDP. NTF is the only hospital facility in the US dedicated to training hospital and healthcare professionals in disaster preparedness and response. [More info on CDP](#)

**Counter Terrorism Operations Support Program (CTOS):** Located at the U.S. Dept. of Energy's Nevada Test Site, CTOS delivers specialized training related to the detection, response, and mitigation of radiological/nuclear incidents, providing responders with hands-on experience in a controlled radiologically contaminated environment. CTOS is a one-of-a-kind outdoor laboratory and experimental center originally established as the Atomic Energy Commission's



on-continent proving ground and has conducted more than four decades of nuclear weapons testing. [More info on CTOS](#)

**Energetic Materials Research and Testing Center (EMRTC):** The New Mexico Institute of Mining and Technology provides specialized training that focuses on explosives and incendiary devices. This training includes controlled detonations of improvised explosives providing responders first-hand understanding of and experience with a range of improvised explosive devices from letter bombs to vehicle bombs. **National Center for Biomedical Research and Training (NCBRT):** Louisiana State University's NCBRT program specializes in curriculum on biological terrorism agents and topics in the law enforcement discipline, including prevention and deterrence.
