# **Meeting Minutes**

# Call to Order/Approval of Minutes/Remarks/Introductions

## Jim Hall, EMC Chair

The meeting was called to order at 9:02 a.m.

**Motion**: Ron Averill moved to approve the minutes. JoAnn Boggs seconded. The motion carried and the minutes were approved.

## **Opening Comments**

#### General Daugherty

- The National Weather service said 2015 could be just as bad as 2014 for floods and landslides
- This is a bad flu season
- Progress on the Cascadia response plan
  - It is published in draft form for input and feedback
  - The governor and the cabinet were briefed on the potential severity of the earthquake
  - Training 150-250 state employees over the next few years for staffing the state EOC
- Thanks to Jim Hall who retired as of December 31, 2014

#### EMD Remarks

Director Ezelle

- 2014 was extremely busy and 2015 is shaping up to be exactly the same
- The State Emergency Operations Center is activated for flooding
  - o Conducting damage assessments
  - Will probably *not* meet thresholds for assistance
  - General Daugherty and Robert will travel to Grays Harbor to observe the damage and see what the state can do to help
- Lots of exercises (and quarterly exercises) planned for 2015
  - 2016 Cascadia Rising exercise is moving forward with FEMA, locals, and the Department of Defense
  - EMD is partnering with the cabinet, locals, and hopefully the EMC
  - o Looking at a joint exercise with the Department of Health
  - Major cyber exercise in spring
  - Oil train scenario later in the summer
  - o End the year with preparations for winter storms
- Monitoring legislation

## FEMA Remarks

Ken Murphy

- Preliminary damage assessments coming out
  - Corps of Engineers has spent a lot of time and energy helping with assessments
- Continuing resolution is ongoing
- Monitoring Ebola and state health
- Reviewing unaccompanied children plans
- Working on Cascadia Rising exercise

# Update SR 530 Slide Commission

Director Ezelle

- The commission's report is out and there are recommendations being made
  - Includes recommendations for: sustainable funding, all-hazard mobilization, and landslide mapping
  - The recommendation for geological mapping did make it in the to the governor's transportation package
- The Emergency Management Advisory Group's work plan includes looking at a statewide emergency management system and structuring of the Joint Information Center/Joint Information System

# State Preparedness Report

John Ufford

- The governor reviewed the package and approved its submission to FEMA
  - Report was submitted before the deadline
- Beginning the AAR process for last year's report
  - Will work with FEMA partners sometime in February for feedback

# EMC Report to the Governor

Dave DeHaan

- A report to the governor is required by the WAC, but the EMC has not submitted one in years
- It is imperative that we complete one for 2014
- Met with OFM, MIL, and EMD to discuss the construct of how the report should look
- Suggest a 1-page executive summary with no more than 20 pages and specific recommendations that should be acted upon
- We currently do not have a process to gather recommendations being made in the name of emergency management
- Referred to past reports, two strategic plans, Resilient Washington, and the SR 530 Report to research what should be in 2014's report
- Take SR 530 report and recommendations and put our stamp of approval on it and highlight specific recommendations (specifically sustainable funding and a statewide emergency management system)
- Create a taskforce to work on the governor's report and submit it in 2015
  - Create the task force under the EMC
    - Reason 1: we are an interdisciplinary organization made specifically for EM.
    - Reason 2: can give them a council to report to on a bimonthly basis.
  - We do not have a good enough definition of sustainable funding
    - Suggest forming a workgroup under the EMC that would specifically define sustainable funding
- The two groups would coordinate efforts
- Topics to mention in report: landslide risk, statewide mobilization, fatality management, and resource management
- The EMAG has stepped up to the plate for the statewide system and resource ordering

# Committee – Task Force Reports

1. EMC Executive Committee (Informal)

Jim Hall

- Will be up to the new EMC chair to select a new committee
- 2. Emergency Management Advisory Group (Action Item)
  - Primary focus is to complete the membership
  - Almost every slot is filled except for small cities and tribal representation
  - First meeting with the new membership this afternoon Establishing terms of service
  - Work plan: statewide emergency management system, JIC/JIS, EOC IMT interface (partnering with EMI for training in the state), and resource ordering
  - Discussing HLS Regional Composition (EMC task)

3. State Emergency Response Commission (SERC) Harris

- Submitted committee report to Dave DeHaan •
- Reviewing gap analysis and CBRNE response
- Will tackle strategic plan for 2015 •
- Currently working with EMD/Lorri Gifford for a sole source letter for a consultant

4. Seismic Safety

#### Ezelle

- Responding to landslides that were unusual because of strange rain patterns •
- Dispatched geologists early in the event and contacted emergency managers and police • and started conducting evacuations.
- Submitted committee report to Dave DeHaan •
- Running legislation for LIDAR
  - o Decision package to increase capacity for the state geological survey for mapping
- 5. Senior Advisory Committee

# DeHaan

- Identifying positions of the EMC that meet the requirements of the SAC
- Have a list of people that are missing from the representation •
- Currently forming a more specific list/recommendation to revise the RCW •
- Need a better method to collect, store, and share recommendations, data, and studies • so we don't have to keep reinventing them
- Under the ad-hoc committee's previous suggestion to reorganize the EMC and create • new workgroups, it would be hard to find a chair and organize consistent meetings
  - Rather than reorganizing, use that structure as a work path to the EMC
- Working to hand off the ad hoc group from Ziggy's unit to Kurt's unit
- 6. Intrastate Mutual Aid (WAMAS)
  - The committee met to look at the draft deployment guide procedures and charter
  - The draft was sent out to EM community for feedback
  - Will meet with the group later this month and hopefully come up with a better product to meet the needs of the constituents and hope to present it to the EMC in March
  - Widen subcommittee invites to the larger and smaller jurisdictions to see how they can support
- 7. Infrastructure Protection Subcommittee
  - No report
