EMC and SAC Clarification (EMC Charter, pg 6)

The EMC serves as the SAC for the purposes of Homeland Security requirements. TAG is also the State Administrative Agent (SAA) concerning the activities and status of emergency management and Homeland Security in Washington State. The SAC component of the EMC is advisory to the SAA. It makes recommendations for integrating whole community preparedness activities with the goal of enhancing the building of core capabilities, maximizing coordination and reducing duplication of effort. The SAC reviews THIRA and SPR for gaps and capability shortfalls and make recommendations for resolution. It also receives information from other programs for incorporation into their recommendations, and assists in determining priorities for those recommendations.

SAC Responsibilities (HSGP Notice of Funding, 2018, pg 51-53)

- Integrating preparedness activities across disciplines, the private sector, non-profit organizations, faith-based and community organizations, and all levels of government, including local, state, tribal, and territorial, with the goal of maximizing coordination and reducing duplication of effort **(EMC)**.
- Creating a cohesive planning network that builds and implements preparedness initiatives using DHS/FEMA resources, as well as other SLTT resources **(All subcommittees touch this topic)**.
- Management of all available preparedness funding sources to ensure their effective use and to minimize duplication of effort **(SAC will review preparedness funding activities and encourage collaboration across the recipient sectors)**.
- Ensuring applications for SHSP and UASI funds align with the capability gaps identified in the THIRA/SPR process **(SAA responsibility)**.
- Assist in preparation and revision of the State, regional, or local homeland security plan or the threat and hazard identification and risk assessment, as the case may be **(All 7 subcommittees provide various information relating to hazard identification, risk assessments, and corrective actions)**.
- Assist in determining effective funding priorities for SHSP. **(Information shared from the 7 subcommittees across the state assists SHSP recipients [State Agencies, HLS Regions, Counties] with allocating funding to fill gaps and priorities)**.
