<b>SUMMARY OF DUTIES:</b>			
Provides mission critical voice, data and video services. Deploys and operates expeditionary communications systems. Establishes priorities, maintains, tests, troubleshoots and repairs network systems equipment and circuits utilizing tools and test equipment. Monitors performance of systems and circuits. Maintains and administers network and circuit databases, records and forms. Conducts periodic inspections of systems installations and repair activities. Applies communications security programs to include physical, cryptographic, transmission and emission security. Manages, supervises and performs planning and implementation activities. Manage resources and personnel which could require after hours phone calls to Airmen and extra unit management meetings. The ability to write awards for personnel recognition at the State and Federal levels.			
<b>OTHER REQUIREMENTS:</b>			
Must have or be able to acquire a TOP SECRET security clearance. For award and retention of AFSC, completion or a current Single Scope Background Investigation (SSBI) according to AFI 31-501, Personnel Security Management, is mandatory. Willingness to set high standards and lead by example.
