SIGNIFICANT EVENTS

- 20-0265
- This mission in response to the Corona Virus (COVID-19) outbreak was initiated on January 21 and continued into July with the State EOC activated at Level 1 (Full).
 - **This mission remained open as of the end of July.**
- 20-1611
- On May 30, the State EOC extended the Level 1 activation already in progress for incident 20-0265 (COVID-19 Virus Response) to cover protests and civil unrest related to the death of George Floyd.
 - **This mission remained open as of the end of July.**
- 20-1912
- This mission in support of a Mount Rainier National Park search for an overdue hiker in the Longmire area was initiated on June 22 and continued into July.
 - On July 7, the National Park requested German Shepherd Search Dogs (GSSD) to assist during the next week. The request was coordinated with Pierce County and the search continued on July 11.
 - On July 20, the National Park closed the search without results.
- 20-1913
- This mission in support of a Mount Rainier National Park search for an overdue hiker in the Paradise area was initiated on June 22 and continued into July.
 - On July 14, the National Park requested cadaver dogs to assist and the request was coordinated with Chelan County.
 - On July 15, the National Park requested Mountain Rescue to assist and the request was coordinated with Pierce County.
 - On July 20, the National Park closed the search without results.
- 20-2020
- This mission in support of a search in Grays Harbor for a missing 29-year-old male in the Taholah area was initiated on June 30 and continued into July.
 - On July 1, the mission was closed when the subject was found in good condition.
- 20-2022
- On July 1, the National Park Service requested Mountain Rescue assets to assist in a search for 3 lost male hikers in the Pebble Creek area. The request was coordinated with King, Kitsap, and Pierce Counties. The mission closed later that day when the subjects self-rescued.
- 20-2052
- On July 2, Mason County initiated a search for an 81-year-old male with possible dementia in the Shelton area. The County requested Ground Searchers (GSAR), air/ground tracking dogs, and ATVs to assist and the request was coordinated with Grays Harbor, Lewis, Thurston, Pierce, Jefferson and Kitsap Counties. A communications vehicle was requested later, and coordination initiated with King and Pierce Counties.
 - On July 3, the subject was located in good condition and the mission was closed.

Washington State Emergency Operations Officer Monthly Report

- 20-2064
 - On July 3, Yakima County opened a rescue of two hypothermic hikers from Mount Adams, a male with significant leg injuries and a female with head injuries. A helicopter with hoist was requested and coordinated immediately with the Air Force Rescue Coordination Center (AFRCC) due to life safety issues for support from the Yakima Training Center. The mission was closed early on July 4 when the subject was rescued and transported to Harborview Hospital.
- 20-2068
 - On July 3, Pend Oreille Dispatch initiated a search for a missing 37-year-old male who fell in the Pend Oreille River. A helicopter from the AFRCC was requested then later cancelled.
 - On July 5, the mission was closed when the subject's body was recovered.
- 20-2073
 - On July 4, Yakima County requested a helicopter with hoist to assist with the rescue of an injured rock climber on Mount Adams. The request was coordinated with King and Snohomish Counties, and then the AFRCC. The mission was closed when the subject was successfully extracted to a local hospital.
- 20-2081
 - On July 4, Kittitas County requested a helicopter with hoist to rescue a 65-year-old injured hiker. The request was coordinated with King County. The mission was closed when the subject was airlifted out and transported to the hospital.
- 20-2102
 - on July 5, Snohomish County initiated a rescue for an injured hiker. A helicopter was requested from AFRCC.
 - On July 6, the helicopter was cancelled, and the mission closed after the subject was assisted out of the area by ground personnel.
- 20-2117
 - On July 7, the Department of Energy (DOE) Hanford declared an abnormal event for response to a wildfire on DOE owned land.
 - On July 13, DOE terminated the Abnormal Event when the fire was declared 100% contained.
- 20-2121
 - On July 7, Chelan County Sheriff's Office requested a helicopter with hoist to rescue an injured climber on Mount Stuart. A helicopter from Whidbey Island Naval Air Station (NAS) was coordinated through the AFRCC. The mission was closed after the subject was rescued and flown to Harborview Hospital.
- 20-2123
 - On July 6, the Centralia PD in Lewis County opened a search for a 93-year-old male
 - On July 12, the Centralia PD requested bloodhounds and cadaver dogs to assist. The request was coordinated with Pierce, Grays Harbor, Kitsap, Thurston, Clark and Cowlitz Counties.
 - On July 13, this mission was suspended without results.

- 20-2131
- On July 8, the Skagit County Sheriff's Office requested a helicopter with hoist and/or Forward Looking InfraRed (FLIR) for a 10-year-old male who flipped over in a kayak on the Skagit River. The request was coordinated with King and Snohomish Counties as well as AFRCC. The county later requested air scent dogs and the request was coordinated with Snohomish, King, Kitsap, Kitsap, and Island counties.
 - On July 9, Skagit County requested cadaver dogs and coordination accomplished with Whatcom, Snohomish and King Counties. The County later requested a cadaver dog and boat operator from Whatcom County to support operations on July 10, and the request was coordinated.
 - On July 10, the County requested Unmanned Aerial Vehicles (UAVs aka drones) to assist and the assets were coordinated with Whatcom and Snohomish Counties. They later added a request for a boat with sonar, which was coordinated with Pierce County.
 - On July 11, Skagit County requested UAVs, a dive team with camera, a communications van, ground searchers, air scent dogs, and cadaver dogs to assist and the assets were coordinated with Snohomish, Whatcom, King, Pierce, Kitsap, Jefferson, and Thurston Counties.
 - On July 12, Skagit County requested UAVs, swift water dive team, pole mounted camera, cadaver dogs, helicopter, and sonar to assist on July 13. The request was coordinated with Snohomish, Whatcom, King, Pierce, Kitsap, Jefferson, and Thurston Counties as well as the AFRCC.
 - On July 13, Skagit County requested GSAR, which was coordinated with King, Pierce, Snohomish and Whatcom Counties.
 - On July 14, Skagit County requested this mission be closed. The child was not located.
- 20-2132
- On July 8, the Olympic National Park initiated a rescue of a 21-year-old subject with a head injury near Findley Creek. They requested Olympic Mountain Rescue to assist and the resources were coordinated with Kitsap County. The mission was closed later that day when the subject was extracted by helicopter and taken to a hospital.
- 20-2143
- On July 9, Mason County initiated a rescue for an injured person. Olympic Mountain Rescue (OMR) was requested from Kitsap County. The subject was escorted out before OMR arrived and the mission was closed.
- 20-2158
- On July 10, the National Weather Service (NWS) issued a Fire Weather Watch affecting portions of Adams, Benton, Chelan, Columbia, Douglas, Franklin, Grant, Kittitas, Klickitat, Lincoln, Walla Walla, and Yakima Counties in effect from the afternoon through evening of July 11.
 - On July 10, the NWS upgraded the Fire Weather Watch to a Red Flag Warning for the above affected Counties from Saturday noon to Saturday evening at 22:00
 - On July 11, the NWS cancelled the Red Flag Warning for the Lower Columbia Basin and Eastern Washington Southern Columbia Basin.

- On July 11, the Red Flag Warnings for Adams, Chelan, Douglas, Grant, Kittitas, Lincoln, and Yakima Counties expired as scheduled. With no Watches, Advisories or Warnings remaining in effect, this weather incident closed.
- 20-2162
- On July 10, Okanogan County initiated the rescue of an injured hiker on the Pacific Crest Trail. A helicopter with hoist was requested and coordinated with King and Snohomish Counties, then the AFRCC. The mission was closed when the subject was picked up and transported to an ambulance for further care.
- 20-2168
- On July 10, Yakima County initiated a rescue for a 32-year-old male with diabetic issues who was hiking on Mount Adams. A helicopter with hoist was requested and coordinated through the AFRCC.
 - On July 11, the mission was closed after the subject was successfully extracted by a helicopter from the Yakima Training Center and airlifted to a hospital in Yakima for treatment.
- 20-2180
- On July 11, Chief John Batiste authorized State Mobilization at 1730 hours in support of the Road 11 Fire in Douglas County.
 - On July 15, State Fire Mobilization ended, and the incident was closed as of 0800.
- 20-2186
- On July 11, Chelan County initiated a rescue for an injured 22-year-old hiker near Blewett Pass.
 - On July 12, the county requested a helicopter with hoist to assist with the rescue. The request was coordinated with King and Snohomish Counties, then the AFRCC. The mission was closed later that day when the subject was extracted via helicopter and transported to a hospital in Wenatchee.
- 20-2193
- On July 12, Olympic National Park requested OMR to support the rescue of a 24-year-old hiker. The request was coordinated with Kitsap County. The request was later cancelled, and the subject was rescued the next day via helicopter, closing the mission.
- 20-2203
- On July 13, Chief John Batiste authorized State Mobilization at 1445 hours in support of the Sunset Fire in Chelan County. The State Fire Mobilization ended, and the incident closed as of 1645 that same day.
- 20-2212
- On July 13, Kitsap County initiated a search for a missing 61-year-old female on Bainbridge Island.
 - On July 14, the county requested search dogs to assist with the search and the request was coordinated with King, Pierce, Snohomish and Grays Harbor Counties. The request was cancelled, and the mission closed later that day when the subject was located in good condition.
- 20-2235
- On July 15, Thurston County initiated a search for a missing 66-y.o. male with Alzheimer's and requested a trailing dog, GSSD and 4x4s to assist. The requests were coordinated with Pierce, Lewis and Mason Counties. The mission was closed, and resources cancelled later that day when the subject was located in good condition.

- 20-2275
 - On July 18, Chelan County opened a rescue of a hiker with a broken leg in the Douglas Creek Recreation Area and requested a helicopter with hoist to assist. The request was coordinated with King and Snohomish Counties and then the AFRCC. The request was later cancelled, and the mission closed when the subject was successfully rescued and taken to the hospital by ground staff.
- 20-2281
 - On July 18, Clallam County opened a rescue of a horse and rider that went over a cliff near Port Angeles. They requested assistance for the horse rescue and coordination was accomplished with King County to connect them with the Washington State Animal Rescue Team (WASART). The mission was later closed without WASART assistance when both horse and rider self-rescued.
- 20-2285
 - On July 18, Grays Harbor County requested OMR to assist with the search for a missing female hiker near Quinault. The request was coordinated with Kitsap County. The request was cancelled, and the mission closed early the next day when the subject walked out on her own.
- 20-2290
 - On July 19, Snohomish County initiated a rescue of a 70-year-old male near Mica Lake who activated an emergency beacon. They dispatched their helicopter to check on the subject and lost contact with the helicopter. They requested a helicopter from Whidbey to assist with both issues and the request was coordinated with King County and the AFRCC. The request was later cancelled when the local helicopter called in with a report the subject was located. The mission was closed later that day when the subject was airlifted out in good condition.
- 20-2293
 - On July 19, Kittitas County opened a rescue for a 28-year-old male hiker stuck between two waterfalls on French Cabin Creek. Rigging crews from Seattle Mountain Rescue and a helicopter with hoist were requested to assist and coordinated with King, Snohomish, Spokane Counties and the AFRCC.
 - On July 20, the rescue was closed early in the morning after the subject was extracted in good condition by a helicopter.
- 20-2316
 - On July 21, Mason County opened a search and rescue for a 48-year old female hiker near the Putvin Trailhead on Forest Service Road 25. County requested GSAR to assist and the resource was coordinated with Thurston, Pierce, Kitsap, and Jefferson Counties. The request was later cancelled, and the mission closed when the subject was located and treated by local fire assets.
- 20-2320
 - On July 21, the NWS issued a Red Flag Warning for East Washington South Central Cascade Valleys affecting Yakima and Kittitas Counties in effect from 1300 to 1800 that day. The Warning expired as scheduled, ending this weather incident.
- 20-2345
 - On July 22, the DNR Pacific Cascade Region requested a helicopter to assist with the rescue of a work crew employee injured by a chain saw. The request was coordinated with the AFRCC. The request was later cancelled, and the mission closed when the subject was treated and transported out by local fire personnel.

- 20-2353
- On July 22, Yakima County opened a rescue for a 23-year-old female hiker with shortness of breath on the SW side of Mount Adams. A helicopter with hoist was requested and coordinated through Snohomish and King Counties, then the AFRCC. The request was later cancelled, and the mission closed when on site treatment was provided allowing the subject to exit the mountain under her own power.
- 20-2357
- On July 23, King County requested GSAR for July 24 to help find an overdue hiker near North Bend. The request was coordinated with Kittitas, Pierce and Snohomish Counties.
 - On July 24, The County requested air scent dogs, which was coordinated with Kittitas County. They later requested additional dogs and GSAR, which were coordinated from Kittitas, Kitsap, Snohomish and Pierce Counties. Cell phone forensics were also requested and coordinated with the AFRCC.
 - On July 25, King County requested a helicopter from Snohomish County, but it was unavailable. King County additionally requested search dogs, GSAR and Mountain Rescue for July 26, which was coordinated with Snohomish and Pierce Counties. The mission was suspended the next day without results.
 - On July 30, King County reopened this mission and requested scent and HRD dogs and the State SAR Planning Unit. The requests were coordinated with Snohomish, Chelan, Kittitas and Pierce Counties.
 - **The mission was SUSPENDED as of July 30, pending additional activities in August.**
- 20-2361
- On July 23, the NWS issued a Red Flag Warning for portions of Chelan, Douglas, Lincoln, Grant, and Adams Counties in effect from 1300 to 2000 on July 23 and 24.
 - On July 23, the NWS issued a Red Flag Warning for Yakima and Kittitas Counties in effect until 2000 that evening and 1300 to 2000 on July 24.
 - On July 24, the NWS expanded the Red Flag Warning to include Douglas, Okanogan, Spokane and Whitman in effect from 1300 to 2000 that day.
 - On July 24, the NWS extended the Red Flag Warning for Spokane & Whitman Counties until 2200 that night. The warning expired as scheduled, ending this weather incident.
- 20-2386
- On July 24, Chief John Batiste authorized State Mobilization at 1830 hours for the Colockum Fire in Chelan County.
 - On July 28, State Fire Mobilization ended effective 1200 hours and the incident was closed.

- On July 25, King County initiated a search for a missing 18-year-old female in the Stevens Pass area. Search dogs, helicopter, and GSAR were requested and coordinated from Chelan and Snohomish Counties to assist with this search on July 27.
 - On July 27, King County requested GSAR and Air Scent Dogs to assist and the resources were coordinated through Chelan, Kittitas, Snohomish, Skagit, and Pierce Counties.
 - On July 31, King County requested Mountain Rescue for August 1 and the request was coordinated with Pierce, Kitsap and Snohomish Counties.
 - **This mission remained open as of the end of July.**

- On July 25, Skagit County requested a helicopter with hoist from Whidbey NAS to rescue lost hikers near Found Lake. The request was coordinated with King and Snohomish Counties, and the AFRCC. The mission was closed when the subjects were extracted in good condition and returned to their vehicle.

- On July 26, Cowlitz County initiated a search for a missing 40-year-old male. The County requested Dog Teams, GSAR and 4x4's, which were coordinated with Lewis, Clark, Pierce, Thurston and Skamania Counties. The request was later cancelled, and the mission closed with the subject was located in good condition.

- On July 26, Skamania County opened a rescue of a female hiker with an injured ankle on the Spirit Falls Trail and requested GSAR to assist. The request was coordinated with Clark, Cowlitz and Lewis Counties. The request was later cancelled, and the mission closed when the subject was able to self-extract.

 - On July 27, the NWS issued Heat Advisories for the East Puget Sound Lowlands, Southwest Interior, Tacoma Area, Lower Chehalis Valley Area, Seattle and Vicinity, and Bellevue Area and Vicinity in effect until 2000 that day.
 - On July 27, the NWS issued Heat Advisories for the Western Columbia River Gorge, Central Columbia River Gorge, I-5 Corridor in Cowlitz County, Greater Vancouver Area, and the South Washington Cascade Foothills until 2100 that day.
 - On July 27, the NWS issued Heat Advisories affecting Adams, Asotin, Benton, Chelan, Columbia, Douglas, Franklin, Garfield, Grant, Klickitat, Okanogan, Walla Walla, Lincoln, Spokane, Whitman, and Yakima Counties in effect from noon that day to 2000 on July 30.

- On July 28, the NWS issued a Heat Advisory for Adams, Asotin, Chelan, Douglas, Ferry, Garfield, Grant, Lincoln, Okanogan, Pend Oreille, Spokane, Stevens, and Whitman Counties in effect until 2000 on July 31.
- On July 28, the NWS issued an Excessive Heat Warning for Adams, Asotin, Benton, Chelan, Columbia, Douglas, Ferry, Franklin, Garfield, Grant, Kittitas, Klickitat, Lincoln, Okanogan, Walla Walla, and Yakima Counties in effect until 2000 on July 31.
- On July 29, the NWS issued a Heat Advisory for the Western slopes of the Cascades affecting Whatcom, Skagit, Snohomish, King, Pierce, and Lewis Counties in effect from 1000 to 2000 on July 30.
- On July 29, the NWS issued a Fire Weather Watch affecting Benton, Columbia, Franklin, Klickitat, Walla Walla and Yakima Counties in effect from the morning to the afternoon of July 30.
- On July 29, The NWS issued a Fire Weather Watch for thunderstorms affecting Adams, Chelan, Douglas, Grant, Kittitas, Lincoln, Okanogan, and Yakima Counties from the afternoon of July 30 through the evening of July 31.
- On July 30, the NWS cancelled the Fire Weather Watch for Garfield, Benton, Klickitat, Yakima, Columbia, Walla Walla, Franklin County, Grant Counties.
- On July 30, the NWS cancelled the Fire Weather Watch for Yakima, Douglas, Okanogan, Kittitas and Chelan Counties.

- On July 30, the NWS issued a Red Flag Warning for the Northern Blue Mountains affecting Walla Walla, Columbia, Garfield & Asotin Counties in effect 1400 that afternoon until 0200 on July 31. The Warning was cancelled later that day.
- On July 30, the NWS issued a Red Flag Warning for Wind and low relative humidity in the East Washington South Central Cascade Valleys affecting Kittitas and Yakima Counties in effect from 1400 to 2200 on July 31.
- On July 31, the NWS upgraded the Fire Weather Watch to a Red Flag Warning for Klickitat County in effect from 1200 to 2100 hours that day.
- On July 31, the NWS issued a Reg Flag Warning for the Lower Columbia Basin & the Southern Columbia Basin affecting parts of Benton, Franklin, Klickitat, Walla Walla and Yakima Counties in effect from 1400 to 2100 that day.

- 20-2441
- On July 28, Jefferson County opened a search for an overdue male hiker/hunter in the Queets River area. Cell phone forensics were requested and coordinated with the AFRCC. The mission was later closed when the subject was located walking out on his own in good condition.
- 20-2442
- On July 28, Chelan County initiated a rescue for an injured climber on Bryant Peak and requested a helicopter with hoist to assist. The request was coordinated with King and Snohomish Counties, then the AFRCC. The mission was closed when Whidbey Island NAS aircraft safely extracted the hiker and transported her to Harborview Medical Center in Seattle.
- 20-2444
- On July 28, Olympic National Park requested OMR assets to assist in a search for a 21-year-old missing hiker at Staircase Trailhead. The request was coordinated with Kitsap County.
 - On July 29, the mission was closed when the subject walked out on his own in good condition.
- 20-2446
- On July 28, Chelan County Sheriff's Office initiated a rescue mission for a hiker with a broken leg and head injuries. A helicopter with hoist was requested and coordinated with AFRCC.
 - On July 29, Navy Whidbey was able to deploy ropes and equipment to assist in moving the patient to a level that he could be picked up.
 - On July 30, Navy Whidbey was able to extract the patient and fly him to a local hospital, closing the mission.
- 20-2449
- On July 29, Chelan County Sheriff's Office requested a helicopter with hoist in support of rescue for a critically injured hiker on the Pacific Crest Trail. The request was coordinated with King and Snohomish Counties. The mission was closed later that day after the subject was airlifted to a hospital for further care.
- 20-2455
- on July 29, Snohomish County initiated a rescue for an injured hiker. A helicopter with hoist was requested and coordinated through King County and AFRCC without success
 - On July 30, Snohomish County requested GSAR from Skagit County to do a pack out. The request was coordinated with Skagit County without success. The mission was closed when the subject was successfully packed out by local SAR and transported to the hospital.
- 20-2476
- On July 30, Chief John Batiste authorized State Mobilization at 2345 hours in support of the Coulee Meadows Fire in Douglas County. THIS INCIDENT CONTINUED INTO AUGUST.

Test information/definitions:

- NAWAS: National Warning System Tests (NAWAS) over the State and Federal circuits. NAWAS connects over 1,800 State and Federal jurisdictions and agencies on the Federal circuit and all counties, some agencies and some tribes on the State circuit. There are four tests a day, two state and two federal, testing 66 drops on two circuits. The number above reflects the four tests a day. Previously the number included the total number of stations contacted during those tests.
- DOE tests: Department of Energy Hanford Site has a dedicated phone and fax line into the EOC and they are tested at least weekly. Only the voice phone line numbers are reported here.
- CGS tests: Columbia Generating Station has a dedicated phone and fax line into the EOC and they are tested at least weekly. Only the voice phone line numbers are reported here.
- AHAB: All Hazards Alert Broadcast System is tested daily through the daily function tests, which tests the functional capability of all coastal and Puget Sound siren systems. The voice and tone sirens are tested monthly. The AHAB Siren activates the coastal and Puget Sound voice and tone sirens during tsunami and other hazardous incidents.
- STAEN: The State Agency Emergency Network (STAEN) connects state agency via an 800 MHz radio system.
- CEMNET: Comprehensive Emergency Management Network radio connecting all counties and many cities via Zetron Radio Console.
- King County 800 MHz System connects the Alert and Warning Center with King County key emergency management and response organizations.
