The RSD working conditions are within the 141st Communications Flight and campus at Fairchild AFB, WA. TDY's and deployments as required to support the mission.

Candidate deploys sustains, troubleshoots, and repairs mission critical data, application, server and file services platforms. Performs, coordinates, integrates, and supervises virtual server environment design, configuration, operation, defense, restoration, and improvements. Analyzes capabilities and performance, identifies problems, and takes corrective action. Evaluates security and logical design of Active Directory objects and policies.
