MINIMUM REQUIREMENTS FOR CONSIDERATION:			
<ol style="list-style-type: none"> 1. Must have a minimum score of 75 on a current AF Physical Fitness Assessment. 2. Physical Requirements: Must be medically qualified in accordance with applicable Air Force and Air National Guard regulations. 3. Must have a minimum of four years retainability from the date of validation. 4. A masters or doctoral degree in the suffixed specialty from an accredited program with specialty board certification; or 5. For award of AFSC 46Y1A/B/C/G/H/M/P, full time enrollment in an AFIT-funded or Health Profession's Scholarship Program graduate level accredited program; or 6. For non-AFIT and non-HPSP trained APRNs, award of AFSCs 46YXX, must be approved by the ANG Chief Nurse 			
SPECIALIZED EXPERIENCE:			
<ol style="list-style-type: none"> 1. Minimum of 6 months full-time nursing practice in the APRN specialty is required. Member must have at least 12 months experience as a registered nurse which MAY INCLUDE the 6 months as a privileged practitioner. 			
OTHER REQUIREMENTS:			
<ol style="list-style-type: none"> 1. Must be assigned to or pending immediate assignment to a position requiring the corresponding 46YX identifier. 2. Credentials must be and remain current. 3. Must not have permanent revocation of all privileges IAW AFI 44-119, Medical Quality Operations. 4. Must attend and complete Commissioned Officer Training (COT) within 1 year. 5. Approval by the Chief Nurse. 			
AREA OF CONSIDERATION:			
All members of the 194 th Wing who hold the 46Y3H AFSC or any member who meets the minimum qualifications to attain the 46Y3H AFSC.			

SUMMARY OF DUTIES:

Provides professional nursing care within scope of practice, established standards of care and federal/state laws. Acts as patient advocate and advances desired health outcomes through patient education. Coordinates with and makes recommendations to staff agencies concerning applicable policies, plans and programs. Participates in cross-functional collaboration to improve patient care delivery. Conducts a variety of health assessments which include: mental health assessments, periodic health assessment questionnaire reviews, and deployment readiness health assessments. Deployment Availability Working Group (DAWG) member; makes recommendations to DAWG chair for Airmen retainability based on current Air Force medical standards guidance; creates narrative summaries (NARSUM) for members selected to enter the Disability Evaluation System. Processes and coordinates Line of Duty packages. Creates fitness, mobility, and duty restricting profiles for Airmen as medically necessitated. Assesses and processes accession, transfer, commissioning, and AGR packages. Conducts other nursing/administrative functions as dictated by the unit's Chief Nurse or Chief of Aerospace Medicine.
