 - \$397/month (*Full-time*)
- ♦ **Montgomery GI Bill–Active Duty, Chapter 30, Effective 1 October 2020**
 - \$2,122 (*Full-time, 3 or more years of service*)
 - \$1,722 (*Full-time, less than 3 years of service*)

What Is It?

The MGIB-SR is a benefit administered by the Department of Veteran's Affairs (DVA) that provides basic educational assistance for traditional/M-day Soldiers actively serving in the Selected Reserve.

How Do I Qualify?

- ♦ Sign a six-year enlistment contract or Officer Service Agreement
- ♦ Have a High school diploma or equivalent
- ♦ Complete Initial Active Duty for Training (IADT) or Basic Officer Leadership Course (BOLC)

What Do I Get?

- ♦ \$397 per month for full-time enrollment
- ♦ Payment is tax free and is made directly to the Soldier each month from the DVA

How Do I Apply?

- ♦ Contact your State Education Office to verify eligibility.
- ♦ Submit the Veterans Online Application at: www.va.gov
- ♦ Notify the VA Certifying Official at your school so they can certify your enrollment
- ♦ Continue to verify your enrollment each month online at: www.gibill.va.gov/wave

What Is It?

An education program that applies to veterans who served on active duty or AGR.

How Do I Qualify?

- ♦ Have qualifying active duty service on or after July 1, 1985, or AGR service after Nov 29, 1989
 - Complete two years on Active Duty or AGR (Title 10/32) for 80% rate
 - Complete three years on Active Duty or AGR (Title 10/32) for 100% rate
 - Must Complete 24 months before use
 - Complete a mobilization of at least two continuous years (730 days), or complete 20 months of a 730 day mobilization and be discharged at the convenience of the government
- ♦ Have pay reduced by \$1,200

What Do I Get?

- ♦ A monthly payment paid directly to the Soldier based on amount of active duty served.
 - 3+ yrs of service = \$2,122 per month
 - 2-3 yrs of service = \$1,722 per month
- ♦ Top Up Program: If on active duty, you can use the MGIB-AD to pay tuition expenses not paid by TA
- ♦ Optional Plus-Up Program: Allows Soldiers to contribute up to an additional \$600 which will increase your monthly benefit up to \$150 per month

- ♦ Notify the School Certifying Official at your school so they can certify your enrollment.
- ♦ Verify your enrollment each month online at: www.gibill.va.gov/wave

What Is It?

An education program for Service Members who serve on active duty after September 10, 2001.

How Do I Qualify?

- ♦ Serve at least 90 days in a period of qualifying active duty on or after September 11, 2001:
 - Title 10 USC Sec's 688, 12301(a), 12301(d), 12301(g), 12301(h), 12302, 12304, 12304a, or 12304b
 - Title 10 AGR or Title 32 AGR
 - Title 32 USC, Section 502(f) under a Declaration of National Emergency as follows:
 - Between Sep 11, 2001 – May 31, 2002 under Operation Noble Eagle
 - Effective February 15, 2019 – in support of the Southwest Border under Operation Guardian Shield
 - Effective March 22, 2020 – in support of the COVID-19 Pandemic (Project Code X-10)
- ♦ Serve for 30 continuous days and separate due to a service-connected disability or injury.

What Do I Get?

- ♦ Tuition and Fees:
 - Up to 100% of in-state tuition at public schools
 - Up to \$25,162.14/year at private or foreign schools
- ♦ Books and Supply Stipend:
 - Up to \$1,000/academic year (\$41.67/ credit hour)
- ♦ Monthly Housing Allowance (MHA):
 - Equal to BAH rate—E5 with dependents
 - \$916.50 if attending only online classes
- ♦ Payments pro-rated based on your percentage tier:
 - 36 Months or purple heart recipient = 100%
 - 30 Months = 90%; 24 Months = 80%
 - 18 Months = 70%; 6 Months = 60%
 - 90 Days = 50%

- ♦ Submit the Veterans Online Application at: www.va.gov
- ♦ Notify the School Certifying Official at your school so they can certify your enrollment.

Overview

The Harry W. Colmery Veterans Educational Assistance Act was signed into law on August 16, 2017. Several changes have been incorporated into our existing GI Bill flyers, below is a summary of recent changes and changes yet to occur.

Effective 1 August 2020:

♦ Payment Tiers

- 40% payment tier is eliminated
- 90 days to 6 months of service eligible for 50% payment tier
- 6 months to 18 months of service eligible for 60% payment tier

Effective 1 August 2022:

♦ Yellow Ribbon

- SMs on active duty are eligible for Yellow Ribbon

Other Changes:

- ♦ VA High Technology Pilot Program
 - Opportunity to enroll in High Tech programs
 - VA determines eligible skills and training based on employer input
 - Can use Chapters 30, 32, 33, 34, 35, 1606, or 1607
- ♦ VA will use automated and electronic processing as much as possible
- ♦ Work Study program continued
- ♦ Schools must report whether they allow priority enrollment for Veterans
- ♦ VA will provide information to schools about all GI Bill programs a Veteran or service member is entitled to (students may opt out)
- ♦ School Certifying Officials must be trained by VA
- ♦ VA will provide counseling on selected campuses
- ♦ Various agencies must provide GI Bill use data reports to Congress
- ♦ Increase in payments to State Approving Agencies

What Is It?

An incentive given upon enlistment/reenlistment to attract Soldiers to specific units, skills, or positions to meet and sustain ARNG readiness requirements.

How Do I Qualify?

♦ Categories:

- Non-prior service applicants (enlisted only); 50 or higher on ASVAB, enlist in a critical skill/unit
- Prior service applicants (enlisted only); 50 or higher on ASVAB, MOS qualified, E-7 or below, and enlist in an MTOE or medical unit
- Currently serving enlisted Soldiers; served between 3-14 years in the ARNG, SFC or below
- Officer commissioning programs; ROTC/SMP, OCS and WOCS
- Currently serving officers; up to one year after commissioning

♦ Basic Criteria:

- Be eligible for the MGIB-SR/Chapter 1606 or MGIB-AD/Chapter 30
- Complete MOS or Branch Qualification
- Sign a six-year service obligation (Extension/Enlistment contract or Officer Service Agreement)

What Do I Get?

- ♦ Depending on your category, **\$200** or **\$350** per month in addition to your basic GI Bill Payment

How Do I Apply?

- ♦ After completing a Kicker contract, submit the Veterans Online Application at: www.va.gov
- ♦ Notify the School Certifying Official at your school so they can certify your enrollment.

Step 1: Apply for your Certificate of Eligibility (CoE)

- ♦ Have all of the required information before you start. You must complete the form in one session – there is no option to save and come back later
- ♦ Go to www.va.gov, click “Apply for Education Benefits” and then “Find Your Education Benefits”
- ♦ Answer the questions by clicking the appropriate bubble until you reach “Apply Now”
- ♦ The VA will process your application within approx. 30 days and you will receive a Certificate of Eligibility (CoE) in the mail
- ♦ Call 888-GIBILL-1 to check the status of your application.

Step 2: Register for Classes

- ♦ Register for classes as soon as your school’s registration period opens
- ♦ Contact your School Certifying Official (SCO) and provide a copy of your CoE

Step 3: Verify Attendance

- ♦ While in school, you must verify your enrollment **EVERY MONTH** to receive your next monthly deposit (Except for Post-9/11 GI Bill)
- ♦ Complete your monthly verification either way:
 - Call: 1-877-823-2378
 - Go online at: www.gibill.va.gov/wave and verify attendance through the Web Automated Verification of Enrollment (WAVE)

Step 4: Next Semester

- ♦ Do not repeat the application on va.gov unless changing schools or degree plans
- ♦ As soon as registration for the next term opens, register for classes early and make another appointment with your SCO

What Is It?

An incentive for continued service offered to Service Members who qualify for the Post-9/11 GI Bill.

How Do I Qualify?

- ♦ Be currently serving in the Uniformed Services, with at least six years completed
- ♦ Qualify for the Post-9/11 GI Bill at any payment tier
- ♦ NOT be flagged for adverse action, APFT/ABCP failure, or as Unsatisfactory Participant
- ♦ Agree to a **four-year** service obligation from the date of your transfer request

NOTE: IF YOU VOLUNTARILY SEPARATE FROM THE ARNG PRIOR TO COMPLETING YOUR OED, YOUR TEB WILL BE TERMINATED AND ANY FUNDS PAID TO YOUR DEPENDENTS WILL BE RECOUPED!

What Do I Get?

- ♦ Dependents receive same payment tier as the Soldier
- ♦ Spouses may use transferred benefits immediately
- ♦ Child/Children:
 - Cannot use the benefit until transferring Soldier has completed 10 years in the Armed Forces
 - Can begin using the benefit on their 18th birthday or upon high school graduation, whichever comes first
 - Eligibility ends on their 26th birthday unless an earlier date is specified
- ♦ You can modify and/or revoke months between any dependent you originally transferred months to – even after you separate from service
- ♦ **IMPORTANT! You must be currently serving to add a new dependent**

How Do I Apply?

- ♦ Step 1: Contact the VA at 1-888-GIBILL-1 to determine the number of months of benefits you have remaining
- ♦ Step 2: Complete extension (If required)
- ♦ Step 3: Got to Milconnect and complete your TEB application at: <https://www.dmdc.osd.mil/milconnect/>
- ♦ Step 4: Access your Enterprise Email and follow email instructions
- ♦ Step 5: Apply for benefits
 - When ready to attend school, your approved dependent(s) apply at: www.va.gov
 - Notify the VA Certifying Official at your school to certify your enrollment

What Is It?

Financial assistance provided for voluntary off-duty education programs in support of a Soldier's professional and personal self-development goals.

How Do I Qualify?

♦ Tier 1:

- Be currently serving in the ARNG and completed AIT, WOBC, or BOLC
- Have not attained a bachelor's degree and wish to pursue an undergraduate academic certificate, associate's or bachelor's degree or
- Have attained a bachelor's degree and wish to pursue a graduate or undergraduate academic certificate or
- Have attained a bachelor's degree w/out FTA and wish to pursue a master's degree

♦ Tier 2:

- Be currently serving in the ARNG and completed either ALC, WOAC, CCC, or equivalent
- Have attained a bachelor's degree w/ FTA and wish to pursue a master's degree

♦ Service Requirement/Obligation:

- Enlisted: Have an ETS or MRD **after** completion of FTA funded course(s)
- Officers and Warrant Officers: Subject to a two-year ADSO or four-year RDSO

What Do I Get?

- ♦ Up to **\$250** per semester hour, up to **16 SHs** per fiscal year
- ♦ Lifetime limit of 130 undergraduate semester hours and 39 graduate semester hours
- ♦ Up to 21 additional SHs towards an academic certificate

What Is It?

The Army's Credentialing Assistance (CA) Program provides Soldiers with funding for more than 1,600 credentials listed on www.cool.osd.mil/army

How Do I Qualify?

- ♦ Complete AIT, WOBC, or BOLC
- ♦ Not be flagged
- ♦ Military Service Obligation (MSO):
 - Enlisted: Complete credential prior to sep/ETS
 - Officers/Warrant Officers: Incur a 2 Yr-ADSO or 4 Yr-RDSO after last day of course
 - Officers/Warrant Officers do not incur a service obligation for Testing or Recertification (capped at \$2,000 on their last year of service)

What Do I Get?

- ♦ Up to \$4,000/year to pay for a new credential or recertification (combined use of FTA and CA cannot exceed \$4,000 per FY)
- ♦ CA pays expenses for course materials/supplies, textbooks, and exam fees.
- ♦ CA can be used for any credential listed on www.cool.osd.mil/army and does not have to be related to the Soldier's MOS
- ♦ All expenses are paid prior to course/exam start date. Soldiers who pay out of pocket will not be reimbursed
- ♦ Popular Certifications:
 - ♦ Project Management Professional (PMP)
 - ♦ Private Pilot, Airplane Single Engine
 - ♦ Certified Personal Trainer (CPT)
 - ♦ Commercial Driver License (CDL)
 - ♦ Emergency Medical Technician (EMT)
 - ♦ CompTIA A+, CompTIA Security +ce

How Do I Apply?

- ♦ Contact your State ESO/ESS to discuss the CA application process and verify eligibility.

What Is It?

APT encompasses standardized tests used to determine eligibility for specialized training and to support the Army's personnel selection and classification process, including language proficiency testing.

How Do I Qualify?

Be an active drilling member of the Army National Guard (ARNG)

What Do I Get?

With APT, Soldiers can take the following tests at no charge to enhance your military career:

- ♦ **Armed Forces Classification Test (AFCT):**
 - Raise GT/Line Scores to Re-class MOS or qualify for Officer Candidate School
- ♦ **Selection Instrument Flight Training (SIFT):**
 - Qualify for Aviation School
- ♦ **Language Tests (DLPT, DLRPT, DLAB and OPI):**
 - Qualify for Foreign Language Billets and Proficiency bonuses

How Do I Apply?

To schedule an APT exam, contact your unit and submit a DA Form 4187 (Request for Personnel Action), signed by the Unit Commander to your state Test Control Officer (TCO).

What Is It?

A combination of on-the-job training and related classroom instruction provided under the supervision of a journey-level craft person or trade professional in which workers learn practical and theoretical aspects of a highly skilled occupation.

How Do I Qualify?

- ♦ Apprenticeship training programs require a minimum of 2,000 hours of OJT per year, supplemented by a minimum of 144 hours related classroom instruction.
- ♦ Instruction may be given in a classroom, through correspondence courses, self-study, or other means of approved instruction.

What Do I Get?

- ♦ As an apprentice, you will receive training, education and wages from your employer.
- ♦ If you qualify for a GI Bill® program, you can also collect a monthly benefit payment 'in addition' to your regular full-time wages, for the duration of the apprentice training period. The amount of the GI Bill entitlement depends on your GI Bill eligibility.
- ♦ Total GI Bill benefits SMs can receive range from \$10-50K over a five year period.
