- 6. Knowledge of computer network operations and AF network cyber surety practices.
- 7. Must demonstrate excellent interpersonal and communication skills, both orally and in writing at all levels.
- Ability to demonstrate strong technical problem solving skills, while providing creative and resourceful solutions.

AREA OF CONSIDERATION:

WORKING CONDITIONS:

Work will normally be conducted inside and subject to 24 hour shift work. This is a mobility position and the successful candidate will maintain personal readiness and comply with all mobility training and other deployment requirements. Though normal duties will be performed in an office environment, occasional duties may be performed in an industrial or recreational setting. Work will be conducted both inside and outside, and possibly in inclement weather.
