Must possess a valid Driver's License to meet deployment requirements.</p> <ul style="list-style-type: none"> - Must set an example in terms of compliance with Dress and Personal Appearance, ANG Fitness Program, and PME requirements. - Members must be able to meet the travel requirements of this position, as well as performing additional planning days required by the Commander. Member is expected to attend all RSD weekends, additional pre-RSD training events, Annual Field Training, site visits, and remain eligible for World Wide Deployments. - Should be familiar with Air Force Inspection System (AFIS), Commander's inspection program (CCIP), and Management Internal Control Toolsets (MICT). - Must be able to complete Combat Mission Ready (CMR) requirements within 12 months of acceptance and maintain CT status annually. This position is located within a Special Warfare Unit. - Members on initial entry or cross-train must be able to meet minimum requirements in AFECD.
