**POSITION TITLE, GRADE, AFSC, FACILITY:**

Cyber Transport Systems Craftsman; MSgt or promotable TSgt, 3D172

**MINIMUM REQUIREMENTS FOR CONSIDERATION:**

The following criteria must be met as of closeout date of this announcement to be considered:

1. Must hold the 3D172 AFSC, at either the 5- or 7-level.
2. Minimum grade for this position is E6/TSgt.
3. Must meet Air Force physical fitness standards IAW AFI 36-2905 with a score of 75 or above (*only applies to current members of the USAF, USAFR or ANG*)
4. Must possess or be able to obtain and maintain a **SECRET** security clearance.

**OTHER REQUIRMENTS:**

Must be a US citizen.

- Must be able to acquire or possess and maintain a **TOP SECRET** security clearance. Must possess a valid Driver's License to meet deployment requirements.
- Must set an example in terms of compliance with Dress and Personal Appearance, ANG Fitness Program, and PME requirements.
- Members must be able to meet the travel requirements of this position, as well as performing additional planning days required by the Commander. Member is expected to attend all RSD weekends, additional pre-RSD training events, Annual Field Training, site visits, and remain eligible for World Wide Deployments.
- Should be familiar with Air Force Inspection System (AFIS), Commander's inspection program (CCIP), and Management Internal Control Toolsets (MICT).
- Must be able to complete Combat Mission Ready (CMR) requirements within 12 months of acceptance and maintain CT status annually. This position is located within a Battlefield Airman Unit.

**AREA OF CONSIDERATION:**

All 3D172 or eligible cross-training members who meet FIT requirements and are members of the Washington Air National Guard or those eligible for enlistment in the Washington Air National Guard.

**SUMMARY OF DUTIES:**

This is a drill status Air National Guard position in the 194th ASOG. Manage 194 ASOG cyber transport systems programs to ensure all requirements are met. Work closely with Commander, section leadership, and host base communications organizations for status, recommendations, coordination, policy and procedure. Provide guidance and conduct staff assistance visits to ASOG subordinate units to ensure compliance with all HHQ guidance.
