Advise commander, staff, and operating agencies of availability, limitations, and requirements for motor vehicles and personnel. Establish work methods and performance standards. Develop operating and administrative procedures. Coordinate manning requirements and manpower personnel. Compile operating costs and maintain expense records. Conduct self-inspections and perform as quality assurance evaluator within Vehicle Operations. Investigate accidents and incidents within functional area. Make official use of Government vehicle determinations. Evaluate and approve special Vehicle requests. Review, interpret, and validate records, directives, and documents. Review contingency, mobility, and natural disaster plans to determine vehicle support requirements.

Meet all worldwide deployable requirements. Must have or be able to acquire a SECRET security clearance.
