SIGNIFICANT EVENTS

- This mission in response to the Corona Virus (COVID-19) outbreak was initiated on January 21, 2020 and continued into January 2022 with the State EOC activated at Level 2 (Partial).
 - **This mission remained open as of the end of January 2022.**
- 21-5133
- On December 31, the National Weather Service (NWS) initiated a weather incident that continued into January 2021.
 - On January 1, the NWS issued a Winter Storm Warning for the Olympic Mountains of Clallam, Grays Harbor, Jefferson and Mason Counties above 2500 feet in effect from 1000 on January 2 to 0400 on January 3. The Warning expired as scheduled.
 - On January 1, the NWS issued a Winter Storm Warning for the Cascade Mountains of Whatcom, Skagit, Snohomish, King, Pierce, and Lewis Counties above 1500 feet in effect from 1600 January 2 to 1600 on January 3. The Warning expired as scheduled.
 - On January 1, the NWS issued a Gale Warning for the Northern Inland Waters including The San Juan Islands, Admiralty Inlet, Puget Sound and Hood Canal in effect from midnight that night through the afternoon of January 2. The Warning was cancelled on January 2.
 - On January 1, the NWS upgraded the Winter Storm Watch to a Winter Storm Warning for the central Washington Cascades of Kittitas, Klickitat and Yakima Counties in effect from the afternoon of January 2 through the afternoon of January 3. The Warning expired as scheduled.

- On January 8, the SEOC added ESF 13 (Public Safety and Security) to its Level 1 – Full Activation in response to the ongoing winter weather and flooding impacts, and the COVID-19 pandemic. ESFs 1, 5, 6, 7, 8, 13, 14, 15, and 20 were activated at that time.
- On January 8, Thurston County requested or 2 swift water rescue units to assist with calls from citizens that need rescue. Request was coordinated with Cowlitz, King, and Pierce Counties.

- On January 15, with all weather watches, advisories, or warnings expired or cancelled, this weather incident is closed for future NWS products but remains open to cover ongoing recovery operations.

- On January 1, Yakima County initiated a search mission for an injured snowmobiler. A helicopter with hoist was requested and coordinated through King and Snohomish Counties, and then the Air Force Rescue Coordination Center (AFRCC). The mission was closed early the next morning after the subject was successfully extracted.
- 22-0129
- On January 7, Thurston County initiated a rescue of an adult male trapped on the roof of a vehicle in a field inundated with swift moving water from the Chehalis River near Rochester. A helicopter with hoist was requested to assist and coordinated with the AFRCC. The request was cancelled, and the mission closed when the subject was extracted by boat.
- 22-0130
- On January 7, San Juan County initiated a search for a 42-year-old female missing from her home on Lopez Island and requested a helicopter with FLIR to assist. Coordinated the request with King and Snohomish County and then the AFRCC. The request was cancelled, and the mission closed when the subject was located and turned over for medical evaluation.
- 22-0225
- On January 15, a large volcanic eruption occurred near the Tonga Islands. The National Tsunami Warning Center issued Tsunami Advisories for coasts of Alaska, British Columbia, California, and Washington. All Advisories for Washington were cancelled late that day with minimal wave action, and it was determined there was no further Tsunami danger for the coast of Washington.
- 22-0286
- On January 20, the National Weather Service issued a Flood Watch for King County in effect from that afternoon through that evening. The Watch expired as scheduled.
 - On January 20, the NWS issued a Flood Warning for the Tolt River above Carnation affecting King County in effect from that morning through the morning of January 21. The Warning was cancelled early on January 21.
 - On January 20, the NWS issued a Gale Warning for Northern Inland Waters Including the San Juan Islands and Admiralty Inlet in effect until late that afternoon. The Warning expired as scheduled.
 - On January 20, the NWS issued a Flood Warning for the Snoqualmie River near Carnation affecting King County in effect from late that night through late night on January 21. The Warning was cancelled on January 21.
 - On January 21, with no Watches, Advisories, or Warnings remaining in effect, this weather incident was closed.

- On January 30, The NWS issued a Winter Storm Warning for Chelan, King and Snohomish Counties until 1600 on January 31. The Warning expired as scheduled, ending this weather incident.

Test information/definitions:

- NAWAS: National Warning System Tests (NAWAS) over the State and Federal circuits. NAWAS connects over 1,800 State and Federal jurisdictions and agencies on the Federal circuit and all counties, some agencies and some tribes on the State circuit. There are four tests a day, two state and two federal, testing 66 drops on two circuits. The number above reflects the four tests a day. Previously the number included the total number of stations contacted during those tests.
- DOE tests: Department of Energy Hanford Site has a dedicated phone and fax line into the EOC and they are tested at least weekly. Only the voice phone line numbers are reported here.
- CGS tests: Columbia Generating Station has a dedicated phone and fax line into the EOC and they are tested at least weekly. Only the voice phone line numbers are reported here.
- AHAB: All Hazards Alert Broadcast System is tested daily through the daily function tests, which tests the functional capability of all coastal and Puget Sound siren systems. The voice and tone sirens are tested monthly. The AHAB Siren activates the coastal and Puget Sound voice and tone sirens during tsunami and other hazardous incidents.
- STAEN: The State Agency Emergency Network (STAEN) connects state agency via an 800 MHz radio system.
- CEMNET: Comprehensive Emergency Management Network radio connecting all counties and many cities.
- King County 800 MHz System connects the Alert and Warning Center with King County key emergency management and response organizations.
