Provides oversight of facility maintenance and repair operations and planning</li> <li>3) Maintains excellent relationships and communications within the Squadron. Serves as the Senior Enlisted Advisor to the Squadron Commander</li> <li>4) Knowledge is mandatory of: contingency engineering, contingency base operations, survivability skills, including force bed-down, expedient damage repair and recovery after attack; methods, sources, and techniques of engineering design, construction, maintenance, operation, and repair of facilities and utility systems; resource acquisition and management; military facilities programming and planning; environmental stewardship; management of real property; fire prevention and protection; engineering research and development; and formulation, coordination, and administration of plans and programs.</li> <li>5) Supervises and manages the traditional Prime Beef enlisted force. Assists with the development of strategic plans for the unit, base, and enlisted force.
