- 5. Facilitates logistical and administrative support needed for the execution of Commander's Inspection Program (CCIP).
- 6. Instructs self-assessment training modules, trains commanders, and educates base personnel on internal assessment issues and procedures.
- 7. Provides IG support serving as a Wing Inspector.
