WORKING CONDITIONS:			
Work will be conducted both inside and outside, and possibly in inclement weather exposed to icy, wet, hot, and slippery surfaces while performing duties.

Position is located in Airfield Management/Flight Services Branch which is responsible for coordinating and maintaining liaison with military, federal, and local agencies concerning airspace utilization, flying operations, aircraft emergencies, search and rescue operations, and natural disasters. This full- performance level position provides direct support to unit and other military and civilian aircrews during scheduled and unscheduled flying and ground activities. The incumbent works independently on standard and extended and/or rotating shifts to provide aircrews with information and assistance necessary for planning and conducting safe flight operations.			
SPECIALIZED EXPERIENCE:			
Must possess integrity of the highest level, with a vast knowledge of the entire Airfield Management/Flight Services arena; specific performance in the 1C7X1 career field and be able to participate in worldwide tasking, deployments and local contingencies.
