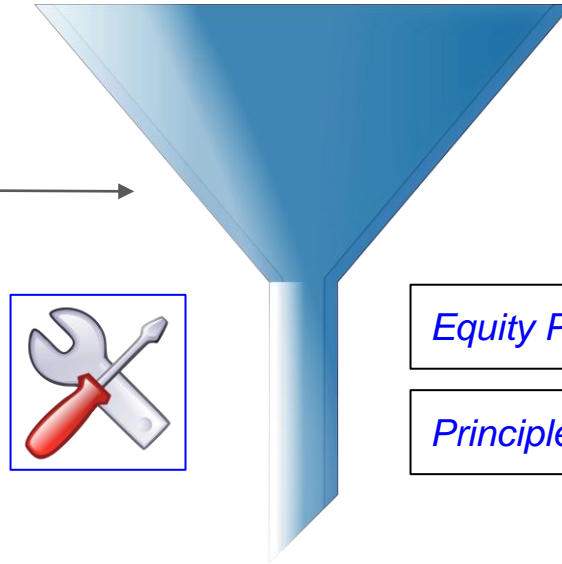

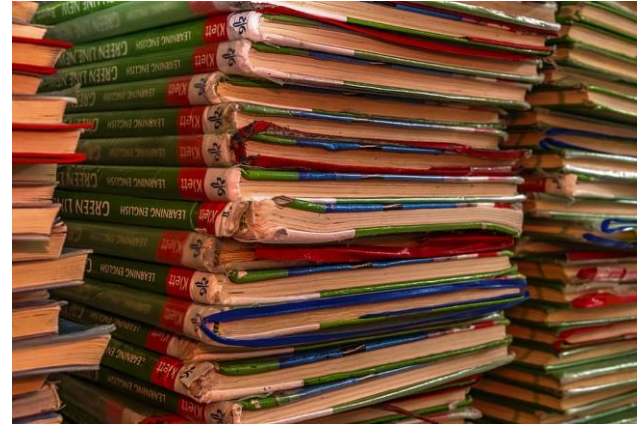

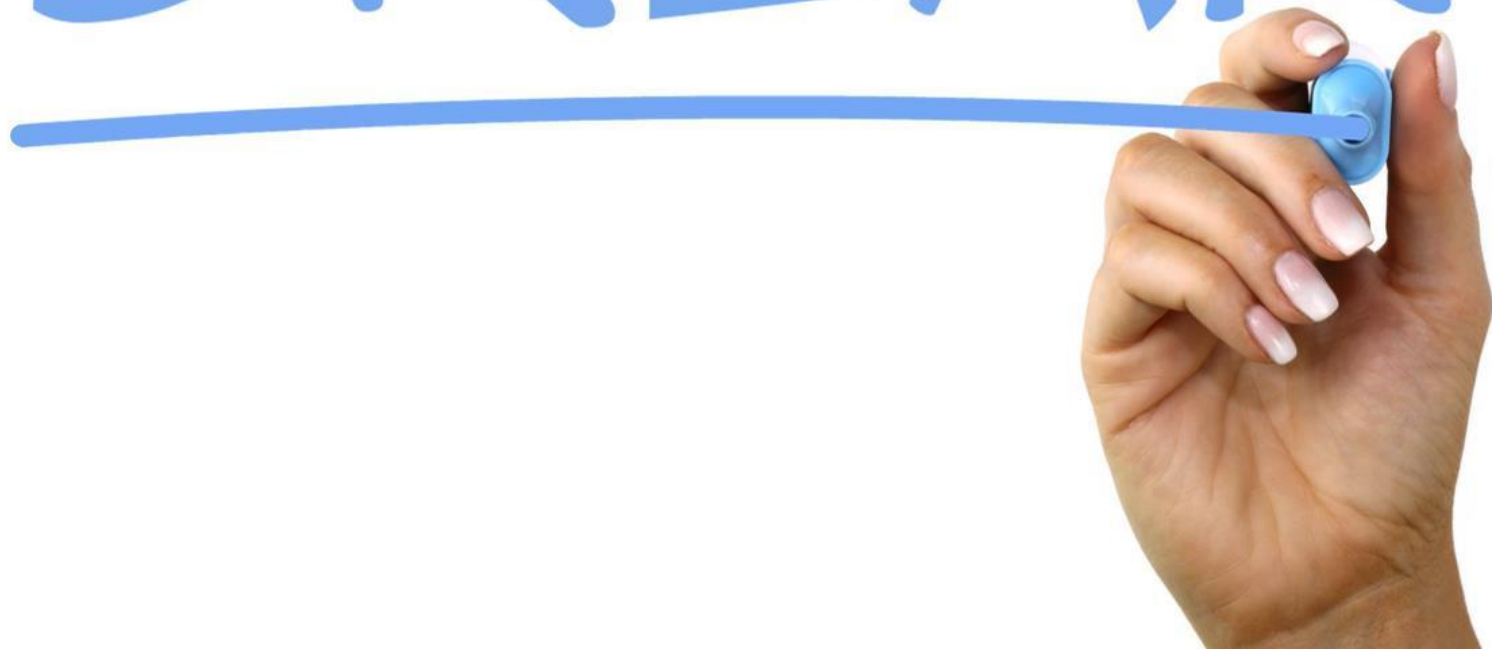
# Equity Gatherings: Update

- Feedback loops
  - Get material up front, have 2 weeks to respond
  - Challenging to document on 'track changes' - set time aside in TF meeting to go over them, use breakouts for different 'sections' to consolidate feedback....15 minute working session to take advantage of collective brain power.

# Examples/Themes: TF Recommendations Update

## Examples of Potential Underlying Themes To-Date:

- Voice
- Respect & Trust
- Decision-Making
- Service Access
- Info Systems/Visibility
- Admin Burden
- Relationships (communities, NGOs, tribal governments, state agencies, local jurisdictions, higher ed, elected officials, service providers, others)
- Organizational/cultural differences
- Resource Gaps and Funding Flexibility

## Examples of Breadth and Depth of Recommendations To-Date:

- *'Trust those who do direct and solution-based work'*
- *'Entrust communities to solve their problems, write the checks and conduct oversight'*
- *'Design a metrics system with communities for reporting and accountability'*



# Examples/Themes: Synthesis of TF Recommendations Update

## More Examples of Breadth and Depth of Recommendations To-Date:

- *'Improve info flow/overflow to reduce tensions between emergency management, electeds and DOH*
- *'Train leaders/others to increase collaborative ability in moments of urgency (e.g., telework environment planning)*
- *'Create templates to help counties operate during crises and reach everyone'*
- *'Make anti-racism a deliberate and necessary part of planning'*
- *'Plan for equity at the forefront'*
  
- *'Simplify state administrative processes, prioritize'*
  
- *'Sustain relationships built between WSDA and the hunger relief sector'*
