# CALL TO ORDER and INTRODUCTIONS

#### WORKGROUPS AND STANDING REPORTS

#### Training Coordination (HazMat Training) –Scott Lancaster

Since the beginning of the year (2022) we have trained over <u>154</u> responders in Awareness, Operations, Hazmat IQ, HM-On Scene Incident Command, and Hazmat Safety Officer.

For the Good of the organization:

I attended great training at the Seattle FD Station 10 on "Lithium Battery" hazards and electric vehicles. Capt. Greene provided case studies and actual lithium-ion battery examples to allow the responders present to see what the technology looks like and how it works. This training also illustrated the various hazards from Lithium-ion battery incidents including scooters, electric vehicles and Energy Storage Systems (ESS).

Battery Technology and Energy Storage Systems are becoming an emerging concern for emergency responders with the increase in battery operated vehicles and energy storage systems throughout the country. Lithium-Ion battery technology and its use in rechargeable electric scooters, bikes, cellphones, and other accessories. The batteries can short out and create what is known has a thermal runaway process of heat and fire reaction. Putting out these fires is difficult if not impossible and even when they appear out, they can reignite hours, days or weeks later. More information is needed to determine proper training and response protocols. Increasing awareness of inspecting and building codes will also need to be reviewed to understand the hazards before they happen.

# **EPCRA Compliance and Outreach – Diane Fowler**

Diane reported that Tier II reports were due March 1<sup>st</sup>. So far, Department of Ecology has received 4,800. This is comparable to the number of reports received last year. She will be sending spreadsheets out to LEPCs for comparison. Diane will be providing an update on the Tier II mobile application during the LEPC-Tribal Conference.

#### **EPA Tier Two Enforcement – Erin Williams**

The Western SERC meeting was held the prior week, which included EPA Regions 8, 9, and 10. A two-day virtual conference was held virtually with over 85 participants in attendance.

The SERC/TERC Handbook is complete and posted to the LEPC Toolbox. If there are any questions, reach out to Erin. EPA had one settlement with SGL in Moses Lake. There will be a press release on this settlement. If LEPCs are having issues with facilities not complying, they can reach out to Erin as they are still focusing on off-site compliance monitoring. #### SERC Budget Report – Kim Mask

Due to Covid-19 and travel restrictions, zero dollars from the Community Right to Know fund were applied to the SERC budget in 2020-2021. However, the SERC did give WSEMA \$5,000 to support their fall conference.

For the next budget cycle, beginning July 1, 2022, the SERC can submit requests to the EMD Budget Manager between now and March 31. Any requests will be reviewed and be allocated to the SERC by July 1, 2022. The maximum funding available will be \$7,000 and include the \$5,000 given to WSEMA to support their conference in September 2022. The additional \$2,000 will be available to the chair/vice-chair attend national conferences and other travel requests to attend in-person meetings.

#### HMEP Grant Update – Zoie Choate

Years 1, 2 and 3 are in progress. The financial update as of April 1:

- Allocated \$865,620
- Expended \$534,056
- Balance \$331,564

#### Strategic Planning Update – Chandra Fox

The draft SERC Strategic Plan was sent out to all SERC members for review following the last meeting. Five initiatives were identified to work on through this phase. There will be a Strategic Planning workshop following this meeting to focus on completing the worksheet and setting deadlines and timelines for the initiatives.
