Receipt and incorporation of this Addendum in the bid proposal shall be indicated on the Bid Form in the space provided.

GENERAL:

1. CLARIFICATION - Q & A:

Note: All pre-bid meetings and any subsequent conversations and observations are considered informal and are not contractually binding unless stated in the contract manual, drawings, or modified by a written addendum.

Question: Would the Owner be able to pay for stored materials as soon as flag poles arrive and are inspected? We would store them offsite in a secure storage unit.

Answer: The contractors are advised to refer **Section 6.03 – Application for payment**, **part D** under Specification Section 007200 General Condition for Washington State Facility Construction.

Question: Does the project require a bid bond?

Answer: Any bid over \$35,000.00 will require a bid guarantee. The contractors are advised to refer **Section 0.02 – Bid Guarantee** under Specification Section 002113 Instructions to Bidders for Washington State Facility Construction.

Question: Does the contractor need to submit a certificate of insurance form with the bid?

Answer: Specification section 006216 Certificate of Insurance Form will not need to be submitted with the bid. The contractors are advised to refer **Part 2 – Insurance and Bonds** under Specification Section 007200 General Condition for Washington State Facility Construction.

Question: Does the contractor need to submit invoice voucher with the bid?

Answer: Specification section 006294 Invoice voucher form A19-2AE2 is not required for bid submission. The contractors are advised to refer **Part 6 – Payments and completion** under Specification Section 007200 General Condition for Washington State Facility Construction.

Question: What forms are required to be submitted with the bid?
