Dangers of fast actuated flight control surfaces and fire. May be subjected to cuts, burns, shock or strain while performing duties.

Conduct local inspections within the maintenance organization in accordance with the Maintenance Standardization and Evaluation Program (MSEP) ensuring processes, programs, maintenance technician proficiency, equipment condition and other focus areas are in compliance with Air Force, Major Command and local directives.</li> <li>4. Support Inspector General (IG) office as a Wing Inspection Team (WIT) member devising scenarios to test and/or inspect readiness and compliance requirements as mandated by Air Force Instructions (AFI) along with drafting simulations (SIMS) and Limitations (LIMS) needed to aid in real world mission requirements.</li> </ol>
