Washington SECC Meeting Minutes

July 9, 2024

The meeting was called to order at 9:30 AM by Chair Ted Buehner. The previous minutes were approved. There were no additions to the agenda.

Announcements

The FCC is considering new rules regarding cyber-attacks. They want to keep "bad actors" from accessing the alerting systems. Broadcasters should already have their EAS gear behind a firewall with solid passwords.

The FCC has launched a rule-making proceeding to improve communications during disasters. They are looking for comments. They are interested in emergency power backup availability at key communications sites and enhancing communications between communications providers and power companies. This is more likely meant for cellular providers than broadcasters.

The FCC has released the results of the last national EAS test. It was a joint effort between the FCC and FEMA for both EAS and WEA. Most respondents reported successful reception of the WEA messages and highlighted areas where WEA delivery could be improved. Reception and re-transmission of the EAS National Test by TV, radio and cable was also mostly successful.

Bill Steele is retiring from the University of Washington and the Pacific Northwest Seismic Network as of early August.

Old Business

The September SECC meeting has been moved to the third Tuesday, the 17th, due to a conflict with the WSEMA conference.

A draft of the 2025 RMT Schedule has been posted on the remailer. Please direct any comments or suggestions to Roland on the remailer.

Regarding <u>WA-PAWS</u> TAB updates, there is nothing new on the bylaws TAB. Ted has posted the Tabletop Exercise TAB on the remailer. He is still looking for more scenarios. Please share on the remailer.

New Business

Gabriel Lotto of the Pacific Northwest Seismic Network (PNSN) gave a presentation on ShakeAlert. It is the publicly funded Earthquake Early Warning

system for the US West Coast. It currently covers Washington, Oregon and California. There are no immediate plans to expand it to other states, but it could happen in the future. It is managed by the US Geological Service in conjunction with several universities and state emergency management agencies. ShakeAlert is not earthquake prediction, but rapid detection. The idea is to give people at least some warning that an earthquake is coming. This could be 10-15 seconds or even a bit longer depending on distance. There has not been an earthquake big enough to trigger the system here in Washington since it was rolled out in 2021. When an alert is generated, a WEA Alert will be sent out to the public via their smart phones. Another possibility is using ShakeAlert to trigger "Customized Automated Actions". Possible actions include slowing trains, recalling elevators, opening firehouse doors, activating generators or many other possibilities. ShakeAlert generates a XML file which is used to originate the WEA alert and any other actions by their technical partners. Is EAS a viable option for delivering ShakeAlert messages? What are the latencies in the system? What sort of messaging and training would be involved? Who are the right people and organizations that ShakeAlert should be connecting with? Keith made the observation that the internet backbone would be the first thing to fail in an earthquake and that the Emergency Alert System is going to be essential. Broadcasters are there 24/7 and they have redundancy. One obstacle is that EAS gets its alerts by poling a server which adds latency to the process. In a major event there will likely be multiple alerts from different sources. Will this get the public's attention and convince them that the event is for real? It is not good to have conflicting messages.

Committee Reports

Technical: Scott has updated the SAGE information. The new SAGE ENDEC Settings Editor allows you to change the input labels. The current version is 2.6.

Training: Ted has been working on the exercise TAB to assist originators.

RMT: Roland has released the draft of the 2025 schedule on the remailer. Please review and post any changes, corrections or comments to the remailer. This will be discussed further at the September meeting.

Local Area Reports

The Central Puget Sound local area is reorganizing.

In Clallam County, Anne Chastain retired on June 1. Justine Chorley is her replacement.

In the Coastal area, they recently had a LECC meeting.

In the Columbia Basin, Steve Williams has retired. He was employed by EMD and helped out with EAS matters. His replacement is Mary Naply. Chris Lee is the new EM director in Walla Walla County.

Austin Smith reports from Wahkiakum County that they no longer have a SAGE. He is working on getting back in the program. Beau has a new position with the sheriff's department. They have a new sheriff who is also the emergency management director.

The North Central area will be meeting in October.

In the North Puget area, there is an application with the FCC for a new LPFM station on Orcas Island. It will cover a good portion of the island.

Stakeholder Reports

The Washington State Association of Broadcasters is working on the AM radio legislation.

In amateur radio, Simone and Monte are working on a TAB that will provide information to emergency managers about what amateur radio can do to support public alert and warning.
