<ol style="list-style-type: none"> 1. Must possess or be eligible for the 1D771Q AFSC upon assignment, complete the suffix-specific course, and meet all worldwide deployment requirements. 2. Must meet all eligibility requirements for promotion to E-6 within 6 months of announcement closure. 3. Must meet the Air Force physical fitness standards. 4. Must possess or be able to obtain a shredout/SEI specific security clearance. For 1D7X1Q – 1AP, 1AL, or 1AM: Completion of a current Tier 5 (T5), Top Secret. For 1D7X1Q – 1AO, 1AK, or 1AR: completion of a current Tier 3 (T3), Secret. 5. Candidates must meet the minimum MAGE or alternate minimum for 1D7X: E:60; or E:55 and Cyber-Test:60 6. All other requirements defined in the AFECD must be met for consideration. 									
SPECIALIZED EXPERIENCE:									
This is not an entry-level position. Prior experience in a Cyber Defense Operations AFSC is required. For entry into this specialty, completion of high school or general educational development equivalency is mandatory. Additional courses in Science, Technology, Engineering, and Mathematics (STEM) are desirable. Associate degree or higher in related fields and/or Information Technology (IT) certification is desirable.
