Work will include but is not limited to, participation in deployed CBRNE Enhanced Response Force Package (CERFP), Homeland Response Force (HRF) exercises in field, both inside and outside, and or in austere conditions.

### **SUMMARY OF DUTIES:**

This position is located within the Medical Group of the 141st Air Refueling Wing, Fairchild Air Force Base, WA. Advises Commander of planning for all mandatory training, exercises, and operations to include the execution of the Yearly Training Plan. Ensures that work methods, production schedules, operating procedures, performance standards, and logistical and medical readiness of the CRE Medical Detachment are followed. Advises budget allocation and activities in accordance with Air Force guidance. Serves as the Medical Element Superintendent with the WA CERFP during exercises and actual responses to domestic disasters.

### SPECIALTY SUMMARY:

Senior Enlisted Advisor to 141 MDG Detachment 1/CC. Senior Enlisted Leader for an

ANG Medical Group responsible for keeping a disaster response force medically ready to deploy worldwide or respond to domestic disasters. Also responsible for providing command support and oversight to CBRNE Response Enterprise (CRE) Medical Detachment, supporting the DET1/CC and providing Defense Support to Civil Authorities (DSCA) medical response capabilities and leading the Medical Element of the CBRNE Enhanced Response Force Package (CERFP)

## **OTHER REQUIREMENTS:**

Meet all worldwide deployable requirements. Must have or be able to acquire a SECRET security clearance. This is a CERFP Superintendent position that may require member to exceed the 30 Annual Training allocations to include possible Friday before drill oversight and attendance. Must be willing to accomplish military related work as necessary on weekdays between UTA weekends.

#### **SPECIALIZED EXPERIENCE:**

Supervises and manage teams while maintaining the highest level of readiness to ensure mission success. Evaluate and assume responsibility for the institutional competencies required to accomplish the mission as outlined in AFI 36-2618. The CERFP Superintendent responsibilities include "management and directives of resource activities as well as interpret and enforce policies and applicable directives. They also establish control procedures to meet mission goals and standards.

Additionally, they recommend or initiate actions to improve organizational effectiveness and efficiency as well as ensure the management of personnel and resources are consistent with current practices and procedures" in support of CERFP mission and NGB directives. The Superintendent must be able to resolve issues between squadrons, other groups, regional CERFPS, and outside agencies as well as perform other duties as directed by the DET 1 and Medical Group Commander.
