Coordinates requirements and standards for cybercrew certification and qualifications in accordance with USCYBERCOM Guidance and ACCIs and ACCMANs. Assists in the creation and dissemination of Group Supplements to ACCIs. Responsible for tracking qualification and training of all HA and NA crew members. Coordinates and assists in conducting Stan/Eval Boards on behalf of 252 COG Commander. Assists in the creation of realistic mission profiles for evaluations. Collaborates with Intel to utilize indicators of compromise and TTPs in evaluation scenarios. Creates and maintains Master Question Files and Secure Question Banks for closed-book and open-book examinations. Conducts evaluations in accordance with ACCI 17-202v2 and ACCMAN 17-2CVAHv2. Consults with subordinates, supervisors, specialists, vendors, and sister IO squadrons to maintain training range devices that realistically emulate Air Force networks and are flexibly re-configurable to emulate the network(s) of a specific Air Force base as needed to prepare for vulnerability assessment missions.
