Unreinforced Masonry (URM) Working Group Updates:

- Updated progress on URM inventory and tax incentive discussions, emphasizing interagency collaboration and a FEMA grant to develop a URM portal.
- Potential URM focused legislative work session in January coordinated by City of Seattle.

Discussion Topics:

- Dave Byers, Department of Ecology, gave a presentation on a summary of the hazmat responses and interesting case studies from the perspective of the Department of Ecology so far in 2024, including:
 - Walla Walla Diesel Spill There was a recent spill into the Columbia River with a coordinated response effort.
 - Illegal Drug Operations -Overview of responses to drug manufacturing facilities, meth labs, and fentanyl-related incidents.
 - Notable Incidents Various impactful environmental and public health incidents, including gas spills and significant cleanup efforts across the state.
 - Pipeline Incident Olympic pipeline gasoline spill near Mount Vernon, highlighting response coordination and financial challenges in recovery and remediation.

- The location and dates for the 2025 LEPC/Tribal Conference and Hazmat Workshops have been planned. The SERC is currently seeking input and participation from members on topics.
 - Hazmat Workshop Scheduled for April 3-6, 2025, at South Puget Sound Community College.
 - o LEPC Conference Scheduled for April 29-May 1, 2025, in Wenatchee, WA.
- National Association of SARA Title III Program Officials (NASTTPO) Update Scott Lancaster,
 Diane Fowler, and Susan Forsythe had a few notes from some of the presentations that were
 highlights of the Conference in October. The SERC will get an update on rule changes to the Risk
 Management Program (RMP) updates at the February Meeting.
