The following modifications to the Project Manual, Specifications and/or Drawings are to be incorporated into bid proposals that may be offered, and the subsequent construction. Bidders shall assess and include the full impact of the revision(s) on any and all related systems and work. Receipt and incorporation of this Addendum in the bid proposal shall be indicated on the Bid Form in the space provided.

Background:

During the past few weeks, enhanced driver's licenses and the REAL ID Act deadline has been a topic of discussion. The purpose of this addendum is to provide clarity and reminder to all bidders regarding ID requirements related to access to the site and the REAL ID Act.

ID Requirements and Access to Camp Murray:

1. Camp Murray is following the REAL ID Act of 2005. This means all personnel who require access to Camp Murray must produce a Department of Defense (DoD) or other authorized credential including one of the following:
 - A. DoD Common Access Card (CAC)
 - B. Defense Biometric Identification System (DBIDS) Card
 - C. Next Generation Uniformed Services ID Card
 - D. Washington State Enhanced Driver's License or Identification Card [only if already registered into DBIDS by the Camp Murray Visitor Control Center (VCC)]
 - E. Veteran Health Identification Card (VHIC) [only if already registered into DBIDS by the Camp Murray VCC]
2. If visitors who require access to Camp Murray DO NOT have an above-mentioned credential, they must be vetted for a Visitor Pass [AF Form 75]. For visitors to qualify for a Visitor Pass, they must produce one of the following:
 - A. A Driver's License or Identification Card that is compliant with the REAL ID Act 2005 [*Enhanced Driver's License or Identification Card*]
 - B. US Passport or Passport Card
 - C. Federally issued Personal Identity Verification (PIV)-1 Card
 - D. Permanent Resident Card/Alien Registration Receipt Card [Form I-551]
 - E. A full list of acceptable credentials, by State, is available at <https://www.dhs.gov/real-id>
3. If a visitor DOES NOT have a REAL ID Act of 2005 compliant credential, as listed in the preceding paragraphs, they will need to produce a combination of source identity documents listed below:
 - A. Transportation Worker Identification Credential (TWIC) + non-compliant Driver's License or Identification Card
 - B. VHIC + non-compliant Driver's License or Identification Card
 - C. Original or certified true copy of a Birth Certificate bearing a raised seal + Social Security Card + non-compliant Driver's License or Identification Card
