Washington SECC Meeting Minutes

March 11, 2025

The meeting was called to order at 9:30 AM by Chair Ted Buehner. The previous minutes were approved. There were no adjustments to the previous minutes nor additions to the agenda.

Announcements

Rebecca Dance is the new administrator for FEMA Region 10. She couldn't be here today because she had another meeting. We also have a new cable representative, Trevor Nelson. He is with Comcast. He could not be here today, either. Carrie Gordon, our Washington State Patrol AMBER representative is retiring in May. She has someone lined up to replace her.

Old Business

The next meeting will be in-person in Ellensburg on May 13th, the second Tuesday of the month. The meeting will be at the fairgrounds instead of the 911 Center. Details will be on the remailer. There will be a virtual option as well.

TAB B2, the SECC Membership Roster, was updated recently. It should be posted to the <u>WA PAWS</u> website soon.

The National Weather Service will no longer activate EAS for Tsunami Watches. This aligns us with the rest of the West Coast.

Simone Ramel-McKay, Monte Simpson and George Long have been working on the new Amateur Radio TAB. The goal is to better educate emergency managers about all the options available to them in terms of emergency communications. Emergency Management, broadcasters and amateur radio operators can work together to support emergency management in getting information to the public when the normal channels are congested or not working.

Amateur radio operates under FCC rules and therefore has some restrictions on its use. The draft is almost ready to be posted on the remailer for comment. It should be ready to be approved at the May meeting. Hardly any other states are doing this. The detail in this document shows the potential for what is possible. Emergency managers do not have to do everything that is listed in the plan. It should be adapted to local conditions and capabilities.

New Business

Originators for the Required Monthly Tests please note that the duration needs to be set for 3 hours. It is a FCC requirement and the purpose is to allow stations receiving the test downstream enough time to air it before it expires.

Also, stations should be checking to make sure their EAS box is actually in the air chain and putting alerts and tests on the air. If you do not receive a scheduled test you are supposed to contact your originator and log the reason. All sub-channels on digital radio and TV need to run the EAS alerts and tests.

AMBER Alerts have a link to social media, specifically X (formerly Twitter). The purpose of this is to provide graphics and further information to the public. X is used because it can best handle the volume of clicks and views that could potentially be generated. If placed on a state website, the concern is that this volume of traffic would crash the website. Otherwise, the message would be text only.

Adam Wasserman is going to be invited to join us at the May meeting to talk about preparations for the World Cup, and public alerts and warnings.

Committee Reports

Technical: Charlie reports that the Burch Mountain NOAA Weather Radio has been rock solid and 100% reliable over the last 4 months.

Training: Nothing new.

RMT: Roland sends out reminders for the RMT originators towards the end of the month.

Local Area Reports

In the Central Puget Sound local area, the King County EM staff were at the KIRO transmitter on Vashon Island site for training by FEMA. They were learning how to operate the station. They are planning to have a LECC meeting soon.

The RMT issues in Clallam County reaching local broadcasters have apparently been resolved.

The Coastal area made it through a recent windstorm. There was some broadcaster and cellular tower damage. They had a LECC meeting in January and plan to have another one in April. They are working on some plan updates. In the Columbia Basin, Sean reported that they did a successful RMT.

The Inland Northwest is having a meeting of their various partners (including Idaho EM) towards the end of May. In September there will be an in-person LECC meeting at KSPS, the Spokane PBS station.

In Kittitas County, AUXCOMM is leading a test of hospital communications between their local hospital and others across the state. In March, Kittitas County Emergency Management launched their first successful RMT. EM has been holding training sessions on how to send EAS and WEA tests and alerts. They will be doing a tabletop exercise in April to walk through the new process for trigger alerts in the county. Central Washington University has started engaging with AUXCOMM regarding alerts and warnings.

In Lewis County, emergency manager Ross McDowell just retired and a new emergency manager is in place. Ted has been having conversations with them over the last month on how they can better engage with the SECC and local LECC.

In Mason/Thurston, they are getting ready for a LECC meeting in April.

In the North Central area, Brady Aldrich has moved to Montana. Charlie has been communicating with Maurice Goodall and they are planning on looking at his LRN equipment installation. There is no near-term prospect for getting a North Central LRN operational. In the Okanagan, Maurice would like to see more training, like possibly have broadcasters observe how alerts are originated in the 911 centers. It would be useful if everybody knew how other parts of the system works. He also suggests that originators listen to the end product and verify that the message is clear and intelligible to the people you are trying to reach.

Stakeholder Reports

WSEM: They are still working on repairing the SRN. They have reached out to Lowell.

WSAB: Keith is working with the state legislature on a number of bills relating to journalism and taxation. Nationally he is working on getting the AM radio in every vehicle act passed. Support is building for this.

Other Business

None.

Required Weekly Tests:

(i) EAS Header Codes and EOM Codes:

(A) Analog and digital AM, FM, and TV broadcast stations must conduct tests of the EAS header and EOM codes at least once a week at random days and times. Effective December 31, 2006, DAB stations must conduct these tests on all audio streams. Effective December 31, 2006, DTV stations must conduct these tests on all program streams.

The same is true for RMTs and alert messages. How to fix the problem is a good question for the equipment manufacturer.
