1.4 CLARIFICATIONS

Joint Base Lewis-McChord (JBLM) recently announced new ID requirements for unescorted visitor access at that base and Camp Murray. These facilities will begin complying with the Federal Real ID Act, which means a standard Washington driver license or ID card will not be accepted for entry. Washington is one of five states whose standard driver license is not in compliance with the federal law. Washington's Enhanced Driver Licenses and Enhanced ID Cards are Real ID Act compliant and require proof of U.S. citizenship, identity and Washington state residence.

Washington residents who plan on visiting a military base in our state must have an Enhanced Driver License, Enhanced ID Card, or another acceptable form of identification to get a visitor's pass for unescorted access to these bases. Acceptable forms of ID include:

- Washington State Enhanced Driver License or Enhanced ID Card
- U.S. Military ID
- U.S. Passport or U.S. Passport Card.
- Permanent resident card (Green Card) or Alien Registration Receipt Card (INS Form I-551).
- Native American tribal document.
- Employment authorization document that contains a photograph (INS Form I-776).
- Foreign passport with a temporary I-551 stamp or temporary I-551 printed notation on a machine readable immigrant visa.
- Foreign passport with a current arrival-departure record or foreign passport with INS Form I-94/I-94A bearing the same names as the passport and containing an endorsement of the alien's nonimmigrant status, if that status authorizes the alien to work for an employer.

- Q1. Two of the buildings have a roof pitch less than 2:12. The specified vertical-rib snap-joint standing seam roof panels *require* a 2:12 slope to achieve the 20-year special weathertight warranty.
- R1. The specified vertical-rib snap-joint standing seam roof panels *recommend* a minimum roof pitch of 2:12. I have verified with Mark Hermans at Taylor Metal Products that Versa Span is approved for all roofs on this project.
- Q2. Is there a Buy American requirement for the metal roofing panels and other materials?
- R2. Yes. The contractor is expected to provide Buy American Certification (reference: WA State Military Department Supplemental Conditions)
