

DR-4775 HMGP - Grant Round Results

Following is a list of grant sub-applications that were submitted to FEMA on April 24, 2025. This round has **\$4,114,533.40 available** for Hazard Mitigation and was based on a Major Disaster Declaration on January 5-29, 2024, for Washington Severe Winter Storms, Straight-line Winds, Flooding, Landslides, and Mudslides. Typical Federal share is 75% of the Total Project Cost.

Awards can take 12-18 months to be approved and awarded. **Primary** applications will receive first consideration by FEMA for approval and award. **Alternates** may be included in more than one round, increasing the visibility and opportunity to move into primary status. Alternates may become primary if additional funding becomes available or a primary sub-application fails to move forward.
