## FM-5499 HMGP Post Fire - Grant Round Results

This round has \$5,253,928.00 available for Hazard Mitigation and was based on 4 Fire Management Assistance Declarations (5521, 5518, 5517, 5499) in 2024. Typical Federal share is 75% of the Total Project Cost.

Awards can take 12-18 months to be approved and awarded. **Primary** applications will receive first consideration by FEMA for approval and award. **Alternates** may be included in more than one round, increasing the visibility and opportunity to move into primary status. Alternates may become primary if additional funding becomes available or a primary sub-application fails to move forward.
