2024 Building Resilient Infrastructure and Communities (BRIC) - Grant Round Results

FEMA cancelled the BRIC program in April 2025. WA EMD submitted its application despite the cancellation.

Following is a list of grant sub-applications that were submitted to FEMA on April 17, 2025. This round was nationally competitive with \$750,000,000.00 available for Hazard Mitigation nationally and includes a state allocation of \$2,000,000.00. The Ranked column below indicates which sub-applications are part of the Washington Allocation. The others are part of the competitive pool.

BRIC is a non-disaster mitigation program funded by Congress. Typical Federal share is 75% of the Total Project Cost but may be higher in some cases.
