



EMERGENCY MANAGEMENT DIVISION

ACTIVITIES/CHALLENGES

- There are multiple changes with the FY16 grant structure that created opportunities to:
 - review the program priorities
 - statewide utilization of these funds
 - and desired outcomes associated with the investment
- At least 75% of the requested federal funding must be dedicated to allowable planning and training programmatic activities
- FY16 Grant Cycle is for a 3-year period of performance ending 9/30/2019
- Continuing State applications will be submitted and reviewed in Year 2 (June 2017) and Year 3 (June 2018)



FUNDING COURSE OF ACTION 1

- 75% to WSP for statewide hazmat training
- 20% to LEPCs-Tribes for training and exercise
- 5% M&A (Management and Administration) to EMD Preparedness Grants Section



FUNDING COURSE OF ACTION 2

- 75% to WSP for statewide hazmat training
- 10% to LEPC-Tribal Conference/Workshop
- 10% to HAMMER Conference
- 5% M&A (Management and Administration) to EMD Preparedness Grants Section

*Potential to use SERC operating budget (\$25,000) to support local projects



FUNDING COURSE OF ACTION 3

- 50% to WSP for statewide hazmat training
- 20% to LEPCs-Tribes to focus on local training needs
- 10% to LEPC-Tribal Conference
- 10% to HAMMER Conference
- 10% M&A (Management and Administration) to EMD Preparedness Grants Section
