SERC Meeting Minutes March 1, 2017 Page 2

CALL TO ORDER and INTRODUCTIONS

Chief Harris called the meeting to order at 10:01 a.m. by welcoming the members and starting with introductions.

REVIEW AND APPROVAL OF MARCH 1, 2017 MEETING MINUTES

Motion: Bill Slosson made a motion to approve the March 1 meeting minutes as written. John Butler seconded the motion. The motion passed unanimously to approve the meeting minutes as written.

WORKGROUPS AND STANDING REPORTS

Training Coordination (Hazmat Training)—Scott Lancaster / Stephanie Hakala

- Scott reported the HAMMER Workshop, held in April, had 120 attendees. Planning for next year's Workshop is already taking place. The location for the Workshop may move to another facility.
- Stephanie briefed about the National Domestic Preparedness Consortium (NDPC) offering free training to first responders. The HazMat for oil trains focuses larger spills but training can be tailored to fit any size agency.

EPCRA Reporting Outreach and Compliance—Sadie Whitener

- For reporting year 2016, 4,740 facilities were compliant in reporting 18,540 chemicals in various location at business sites. EPA has a list of 150 delinquent facilities. (See report at end of minutes)
- Regional 10 settles with Christensen, Inc. (Grandview, WA) for EPCRA 312 violations
 - On April 7, 2017, Region 10 filed a consent agreement and final order to settle with Christensen, Inc. to resolve violations of EPCRA 312for failing to report storage of diesel, gasoline, LGP-propane, and motor oils at six of their distribution facilities in Washington. Christensen, Inc. agreed to pay a penalty of \$65,670 and implement a \$304,385 Supplemental Environmental Project (SEP) that includes the installation of electronic, web-based monitoring systems on at least 180 underground storage tanks owned by their customers.

Budget Report —TJ Rajcevich

- Would like a recommendation to move the surplus of \$20,000 still left to the \$24,000 for the state match. In the past, EMPG was the match for pass through to the locals, but moving forward, it cannot. Currently, the SERC uses six separate fund sources. A motion was made and seconded. All unanimously approved.
- Would like the creation of the SERC Budget Workgroup. The mission of the workgroup is to review SERC workplan and look at all funding components for LEPC.
- The best use of this fund would be to support LEPC projects. The LEPC would apply directly to the SERC for approval. Use to support regional training.
- Chuck Wallace suggested to create a small workgroup to look at where the money would be most beneficial and brief back to the SERC. It was asked that funding continue for the statewide HazMat training provided by the WSP.

HMEP Grant Status/Workgroup—TJ Rajcevich

There are multiple changes with the FY16 grant structure creating opportunities to review the
program priorities. At least 75% of requested funds must be dedicated to planning and training
activities. The FY16 grant cycle is a 3-year performance period, ending 9/30/19.

- TJ gave three funding options to explore:
 - 1) 75% to WSP for statewide HazMat training, 20% to LEPCs and Tribes for training and exercises, and 5% to EMD Preparedness Grants section for management and admin of the grant.
 - 2) 75% to WSP for statewide HazMat Training, 10% to LEPC Tribal Conference/Workshop, 10% to HAMMER Conference, and 5% EMD Preparedness Grants section for management and admin of the grant. (Potential to us SERC operating budget [\$25,00] to support local projects.
 - 3) 50% to WSP for statewide HazMat training, 20% to LEPCs and Tribes to focus on local training needs, 10% to LEPC Tribal Conference, 10% to HAMMER Conference; 10% to EMD Preparedness Grants section for management and admin of the grant.

(* Action completed after conclusion of meeting: Option (3) was selected after a poll was conducted during the LEPC Conference.)

LEPC Planning Status / WAC 118-40 Update—TJ Rajcevich for Susan Forsythe

- Had three counties meet all 9 of the requirements. They were Kitsap, Yakima, and Mason Counties. Lewis County and City of Yakima were very close to meeting the requirements.
 - WAC 118-40 Update was not discussed. This topic was tabled until next meeting.

Strategic Plan Review—Chief Harris

• Will send out a Google Poll to attempt to set up a meeting. Would like this to be a face to face meeting. It is very important that the Strategic Plan review be accomplished.

Update from EMC—Chief Harris

- The EMC had a very full agenda. There was not enough time to do SERC presentation due to time constraints and multiple presentations.
- The EMC has tasks all subcommittees to develop workplans. John Ufford is not sure who has completed their plans, including the SERC.

SERC Members vacancies—Chief Harris

- OSPI Need to reach out to the school directors association. Bill Slosson volunteered to reach out.

SERC Bylaws Update—John Ufford

 Met after the last meeting in March to review the bylaws. They are still needing to finalized for comment. Going to go back and review EPCRA to make sure they are compliant.

LEPC Guide Approval—Susan Forsythe

• The draft is continuing to be reviewed. Will be moved to Old Business for next meeting to be reviewed.

- Currently \$77,000 spent with 63% going to Fire, 11% to Tribes, 10% to County Emergency Management, 7% to Dept. of Agriculture, and 3% to ports.
- Next grant cycle will be two years. Will be able to do longer projects. Applications open September 1, 2017. The focus will be hazmat for the next grant period. EMD would also be eligible to apply for this.
